A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AWARDED BID NO. 969-19-2 TO HARTNETT BUILDING GROUP OF FORT PIERCE, FLORIDA TO RENOVATE THE LOCKER ROOM AT FIRE STATION #1 AMOUNT OF \$184,100.00; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT; AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO TEN PERCENT (10%); AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENT FOR SAME FROM PROJECTS 18033; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council approved, through Resolution No. 63-18, the creation of a new capital sheet for the renovation of locker rooms at Fire Station #1; and

WHEREAS, the Public Works Department has completed bathroom renovations in City Hall and the Library, current condition of the restrooms in both the police and fire station has not been completed; and

WHEREAS, the current condition of the restrooms in both the Police and Fire Departments are deteriorated and impacting operations; and

WHEREAS, Hartnett Building Group LLC. of Fort Pierce, Florida was the lowest responsive and responsible bidder.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA as follows:

SECTION 1. The City Council hereby accepts the bid proposal and awards a Construction Services Contract to Hartnett Building Group LLC., the lowest responsive and responsible bidder in the amount \$184,100.00 to renovate the locker room at Fire Station #1.

SECTION 2. The Director of Finance and Administrative Services is authorized to make payment from Project 18033.

SECTION 3. The City Manager is authorized to approve Change Orders up to ten percent (10%).

SECTION 4. The Mayor and City Clerk are authorized to execute the Contract.

SECTION 5. That the Resolution takes effect upon its passage and approval by City Council.
