## **RESOLUTION NUMBER**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH UTILITY SPECIAL DISTRICT, PALM BEACH COUNTY, FLORIDA, APPROVING THE CONTRACT WITH TANNER INDUSTRIES, INC., OF SOUTHAMPTON, PA; BID NO.19-146, ANHYDROUS AMMONIA, TANK RENTAL AND TANK MAINTENANCE SERVICES CONTRACT ON AN AS NEEDED BASIS. AUTHORIZING THE UTILITY DISTRICT CHAIRPERSON AND DISTRICT CLERK TO EXECUTE THIS CONTRACT; AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO TEN PERCENT (10%); AND AUTHORIZING THE FINANCE DIRECTOR TO MAKE PAYMENT FROM PROJECT NUMBER 41131103 543000 IN AN AMOUNT NOT TO EXCEED \$50,000; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** Tanner Industries, Inc., of Southampton, PA is awarded Bid No. 19-146 effective until June 30, 2021; and

**WHEREAS**, the district is the lead agency for the Southeast Florida Governmental Purchasing Cooperative and the above mentioned solicitation will provide services for the district and approximately fourteen other agencies; and

**WHEREAS,** the contract allows Tanner Industries, Inc., to provide Anhydrous Ammonia tank rental and the maintenance of tanks to include labor, material and equipment on an as needed basis; and

**WHEREAS**, the Utility Special District wishes to utilize Tanner Industries, Inc., Bid 19-146 in an amount not to exceed \$50,000 annually.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH, UTILITY SPECIAL DISTRICT, RIVIERA BEACH, FLORIDA, AS FOLLOWS:

**SECTION 1:** That the Utility Special District Board approves the contract with Tanner Industries, Inc. in the amount not to exceed \$50,000.00 annually to provide equipment on an as needed basis.

**SECTION 2:** That the Utility Special District Board Chairperson and the District Clerk are authorized to execute the contract between the Utility Special District and the above named vendor.

**SECTION 3:** That the District Finance Director is authorized to pay for same under Account Number 41131103 543000.

**SECTION 4:** That the Chairperson and District Clerk are hereby authorized to execute future renewals of this agreement.

**SECTION 5:** This Resolution shall take effect upon passage and approval by the Utility Special District Board.
