**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY (THE AGENCY) APPROVING AND AUTHORIZING EXECUTION OF PROFESSIONAL SERVICE AGREEMENTS WITH STREET ART REVOLUTION, LLC, FONDOS STUDIO LLC AND BIG “D” GRAFIX, LLC FOR PUBLIC ARTWORK AND PAINTING SERVICES AT DESIGNATED PROPERTIES WITHIN THE CRA DISTRICT; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, The Agency is responsible for carrying out community redevelopment activities and projects in the community redevelopment area of the City of Riviera Beach pursuant to the Adopted Community Redevelopment Plan (the “Plan”);

**WHEREAS**, the Plan encourages the beautification of the Community Redevelopment Area (CRA) which is implemented through the Riviera Beach Art & Beautification Project (the “Project”)

**WHEREAS**, in accordance with the provisions of the Agency’s procurement policies, Agency Staff previously solicited Request for Qualification for Artist and Painting Services (RFQ); and

**WHEREAS**, three (3) firms responded to the RFQ; and

**WHEREAS**, the Agency entered into separate agreements with each of the three responding firms: Street Art Revolution, LLC, Big “D” Grafix, LLC and Fondos Studio LLC, to complete various components of the Project; and

**WHEREAS**, Staff has identified additional components of the Project and desire to negotiate contracts with the original three responding firms to insure continuity and uniformity with the original artwork; and

**WHEREAS**, the Board of Commissioners of the Agency authorized Staff to enter into negotiations with the the three Artists.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY THAT:**

**SECTION 1.** The Board of Commissioners of the Riviera Beach Community Redevelopment Agency hereby approves the attached Professional Service Agreements between Street Art Revolution, LLC, Big "D" Grafix, LLC and Fondos Studio LLC, and the Agency for the installation of murals at locations specified in the Agreements.

**SECTION 2.** The Chair and the Executive Director are hereby authorized and directed to execute and attest, respectively, those certain Professional Service Agreements substantially in the forms attached hereto as Exhibit "A", "B" and "C" subject to such changes as may be approved by the Chairperson subject to advice of counsel, with the execution of the Agreement by the Chairperson conclusive evidence of the approval of such changes.

**SECTION 3.** This resolution shall be effective immediately upon its adoption.
