## **RESOLUTION NO. 2019-**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY (THE "AGENCY") APPROVING AND AUTHORIZING THE EXECUTION OF THE PROFESSIONAL SERVICES AGREEMENT FOR **TECHNOLOGY** INFORMATIONAL **SERVICES** CONSTANT COMPUTING, LLC ("CONSTANT COMPUTING") AND THE AGENCY FOR A TERM OF TWO YEARS WITH A ONE YEAR OPTION UPON THE SAME TERMS AS THE ORIGINAL AGREEMENT FOR AN ANNUAL AMOUNT NOT TO EXCEED \$85,140.00 WITH A 9% CONTINGENCY FOR A TOTAL ANNUAL AMOUNT NOT TO EXCEED \$92,802.60; AMENDING THE ADOPTED 2019-2020 BUDGET TO INCREASE THE IT SERVICES BUDGET BY \$31.802.60 AND DECREASING THE AGENCY ADMINISTRATIVE **BUDGET BY THE SAME; AUTHORIZING AN APPROPRIATION FOR** THE FIRST YEAR FROM THE FY 2019/2020 AMENDED BUDGET: PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** in accordance with the provisions of the Agency's procurement policies, the Agency published RFP 2019-03 soliciting proposals to provide professional informational technology services to the CRA; and

WHEREAS, five (5) firms responded to RFP 2019-03; and

**WHEREAS**, the Constant Computing, LLC ("Consultants"), was deemed to be the best and most responsive respondent by the evaluation committee; and

**WHEREAS**, Board of Commissioners of the Agency authorized staff to negotiate a contract with the Consultants.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY THAT:

**SECTION 1.** The Agency approves and authorizes the execution of the Professional Services Agreement with Constant Computing, LLC attached hereto as Exhibit "A" for a term of two years ('Original Agreement") with a one year option upon the same terms as the Original Agreement.

SECTION2: The Agency hereby amends the Adopted 2019-2020 Budget to reallocate \$31,802.60 to the IT services line item and decrease the administrative development professional services line item by the same. The total IT budget for

2019/2020 is increased from \$61,000.00 to the new maximum contract amount of \$92,802.60 for the CRA offices, Marina Village & the Clean and Safe offices.

SECTION 3. The Agency authorizes and appropriates in an amount not to exceed \$85,140.00 with a 9% contingency for a total not to exceed \$92,802.60 for not the first year from the 2019-2020 fiscal year budget.

**SECTION 4.** The resolution shall be effective immediately upon its adoption.
