**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING SETTLEMENT IN THE CASE OF SARA GOODMAN V. THE CITY OF RIVIERA BEACH, CASE NO.: 502019CA004472XXXXMBAY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on or about February 6, 2019, Sara Goodman (“Plaintiff”) filed a Petition for Writ of Mandamus against the City of Riviera Beach in the Circuit Court of the 15<sup>th</sup> Judicial Circuit, in and for Palm Beach County, Florida, Case No. 502019CA004472XXXXMBAY; and

**WHEREAS**, the Plaintiff alleged that the City unlawfully refused to transmit Plaintiff’s appeal to the City’s Development Special Magistrate regarding the application of off-site parking laws to a pending application for approval to redevelop what is generally known as the “Crab Pot” site; and

**WHEREAS**, the parties, after mutual negotiation, have reached a settlement to resolve this matter, as outlined in the attached “Settlement Agreement”; and

**WHEREAS**, as a condition of settlement, the City agrees to schedule a City Council workshop on the Crab Pot Redevelopment at a time mutually agreed upon by both parties and before any action is taken with respect to the Crab Pot; and

**WHEREAS**, as a condition of settlement, the Plaintiff agrees to file a Notice of Dismissal of the Petition; and

**WHEREAS**, the City finds that authorizing this Settlement Agreement is in the best interests of the City and serves a valid public purpose.

**NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:**

**SECTION 1.** That Settlement Agreement in the matter of Sara Goodman v. The City of Riviera Beach; Case No.: Case No. 502019CA004472XXXXMBAY is hereby approved.

**SECTION 2.** That this resolution shall take effect immediately upon its passage and approval by the City Council.
