A RESOLUTION OF THE CITY COUNCIL OF THE OF RIVIERA BEACH. PALM COUNTY, FLORIDA, AUTHORIZING A CHANGE ORDER IN THE AMOUNT OF \$237.675 MARINETEK NORTH AMERICA, INC., PETERSBURG, FLORIDA, A SUBSIDIARY MARINETEK GROUP OY OF HELSINKI FINLAND; AUTHORIZING THE FINANCE DIRECTOR TO ESTABLISH A BUDGET AND MAKE PAYMENTS FOR SAME; AND PROVIDING AN EFFECTIVE DATE.

Whereas, staff has determined the total cost to replace the City marina docks including the seawall eastward to the dedication line is approximately 17 million dollars, and

Whereas, consistent with the provisions of the City's Procurement Ordinance (4010), a Request for Proposal was publicly solicited for qualified dock manufacturers to furnish all supervision, personnel, equipment, materials, labor and supplies to complete the manufacturing and installation of all fixed, floating docks and related structures and components, and

Whereas, one (1) manufacturer responded to the Request for Proposal No. 950-18-3, and.

Whereas, Marinetek North American, Inc. of St. Petersburg, Florida, a Subsidiary of Marinetek Group Oy of Helsinki Finland (Marinetek) was evaluated and the proposal was found to be responsive and reasonable to provide a fixed and floating dock system as identified in the City's Request for Proposals, and

Whereas, the initial award of a contract (Resolution No. 104-18) did not provide authorization for the manufacture of the docks for Pier E as the City was awaiting a FIND grant award, and

Whereas, the City has received a \$250,000 FIND grant award for Pier E, and

Whereas, staff recommends City Council approve the change order with Marinetek in the amount of \$237,675 for the completion of Pier E, and

Whereas, the amount of \$237,675 exceeds the City Manager's change order approval authority

Now, therefore, be it resolved by the City Council of the City of Riviera Beach, Florida that:

Section 1. The City Council hereby accepts staff's recommendation to approve a change order with Marinetek in the amount of \$237,675 to complete the manufacturing and installation of the fixed and floating docks and related fixed structures and components for Pier E.
