A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AWARDED RFP NO. 982-19-4 SUPPLY VERTICAL BOAT LIFTS AT THE CITY OF RIVIERA BEACH MARINA TO GOLDEN MANUFACTURING, INC. OF NORTH FT. MYERS, FLORIDA IN THE AMOUNT OF \$186,588, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT FOR SUPPLY VERTICAL BOAT LIFTS; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENT UNDER THIS CONTRACT FROM PROJECT 18058; AND PROVIDING AN EFFECTIVE DATE.

Whereas, for the last several years the City of Riviera Beach has improved and expanded City of Riviera Beach Marina using grant funding, and

Whereas, three (3) companies responded to Request for Proposal (RFP) 982-19-47, and

Whereas, Golden Manufacturing, Inc. of North Ft. Myers, Florida submitted the highest ranked and the lowest responsive and responsible proposal in the amount of \$186,588, and

Whereas, the City desires to continue completion on the Marina project as set forth in the Scope of Services detailed in RFP 982-19-4.

Now, therefore, be it resolved by the City Council of the City of Riviera Beach, Florida that:

Section 1. The City Council hereby accepts staff's recommendation to award the contract of supply of boat lifts for the City of Riviera Beach Marina to Golden Manufacturing, Inc.

Section 2. That the Mayor and City Clerk are authorized to execute the contract.

Section 3. This Resolution shall take effect upon its passage and approval by the City Council.
