**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AUTHORIZING THE TEMPORARY CLOSURE OF NORTH OCEAN AVENUE FOR THE HAMMERHEAD PRODUCTION FESTIVAL – “JEEPS ON THE ISLAND”; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Hammerhead Productions is requesting temporary closure of North Ocean Avenue to conduct the “Jeeps On The Island” Festival being held on March 21 and 22, 2020; and,

**WHEREAS**, staff is requesting authorization to temporarily close North Ocean Avenue immediately behind the Ocean Mall in an effort to provide designated safe and sufficient space to conduct the Festival activities.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA that:**

**SECTION 1.** Authorization is given to temporarily close North Ocean Avenue on March 21, 2020, from 1 p.m. until 10 p.m. and March 22, 2020, from 6 a.m. until 9 p.m.

**SECTION 2.** This Resolution shall take effect immediately upon its passage by the City Council.
