15	CHAIR BOTEL: Thank you.
16	I believe that there will be a presentation
17	by Mr. Haygood outlining the process for hiring a
18	either doing a national search or doing it in-house.
19	So Mr. Haygood, please.
20	MR. HAYGOOD: Yes. Well, we were trying to
21	address, I guess, two areas, really not to recommend to
22	the Board one process over another. We talked with the
23	Clerk's Office, and I think the not the Clerk, the
24	Human Resource Office, and I think the Director's out,
25	she had a death in the family, so her assistant was

- 1 going to be here for backup.
- 2 Basically, I know of two ways that we can
- 3 proceed, or that the Board can proceed as far as the
- 4 recruitment is concerned. We've discussed it briefly
- 5 at the last meeting. The first is to do a national
- 6 search, which would require retaining a firm, I guess a
- 7 headhunter firm, to actually do a -- as I understand
- 8 it, the option is to do a national search. And the
- 9 other means of doing it is to do a search -- I guess
- 10 you could use a headhunter even to do just a search in
- 11 Florida as opposed to a national search.
- 12 I don't have a lot of information as to cost.
- 13 I asked her, I think it was the last City Manager
- 14 recruitment, and she said it could go from 25 to
- 15 \$30,000. I guess it's really how involved are you
- 16 going to have the headhunter.
- 17 The other option is to do it on a local
- 18 basis, local being statewide, using some various
- 19 publications and/or the Municipal League of Cities, the
- 20 Florida Department -- I mean the Florida, what is it,
- 21 Redevelopment Association. I know they have a site
- 22 that will publish, actually put up advertised
- 23 positions, as well as doing some other publications.
- And then talking about, I guess, a timeframe
- 25 in which to do this, was the -- and then that's just

Page 6 1 something we'd have to get directions from you all. 2 CHAIR BOTEL: Thank you. 3 COMMISSIONER MILLER-ANDERSON: Madam Chair. CHAIR BOTEL: Go ahead. Thank you. 4 COMMISSIONER MILLER-ANDERSON: Ms. Dickerson 5 6 is here. Is she able to give more information? She seems like -- well, she signed in. Is she able to 7 provide some of that information as well? MR. HAYGOOD: You mean as far as cost is 9 10 concerned? 11 COMMISSIONER MILLER-ANDERSON: More details 12 about it. MR. HAYGOOD: I don't know how much more 13 14 detail we could give you at this point. I mean you'd 15 advertise for a headhunter to come -- I mean to come 16 in, hire him, and then I guess we'd discuss the process 17 of how you wanted to actually do it. 18 COMMISSIONER MILLER-ANDERSON: Are we able to 19 hear from her? 20 CHAIR BOTEL: Rosilyn Dickerson, can you turn 21 on your microphone and your camera, please? 22 Ms. Dickerson? Thank you. And your camera? 23 Ms. Dickerson, are you there? 24 MS. DICKERSON: Good evening. This is 25 Rosilyn. I'm not able to turn on my camera, but I'm

- 1 happy to speak as much as I can.
- 2 Good evening, everyone. I do have Eureka
- 3 Young on the line as well, you know, in case there, you
- 4 know, are areas that I can't address due to limited
- 5 experience with the City.
- But from what I understand, you're looking to
- 7 hire the Executive Director for the CRA. And
- 8 Mr. Haygood is correct, you could use an executive
- 9 search firm, which is often the best approach or the
- 10 best practice for the senior level positions of this
- 11 nature.
- On average, a position of this nature costs
- about 25,000 per position. They would do the extensive
- 14 search, sourcing, finding the candidates, presenting a
- 15 candidate slate to you, also performing background
- 16 checks, assisting -- it really depends on the level of
- 17 minutiae that you want them to be involved in. But you
- 18 would provide them with, you know, what you're looking
- 19 for in the next candidate, and they would do a broad
- 20 search for candidates who would provide a matching
- 21 skill set, knowledge, skills and ability. And they
- 22 would pretty much handle, mutually exclusively, of
- 23 course, and then present you with candidates after
- 24 they're screened and checked references and things of
- 25 that nature.

1	CHAIR BOTEL: Thank you.
2	COMMISSIONER LANIER: Madam Chair.
3	CHAIR BOTEL: Go ahead, Ms. Lanier.
4	COMMISSIONER LANIER: Madam Chair.
5	CHAIR BOTEL: Yes, go ahead, Ms. Lanier.
6	COMMISSIONER LANIER: I wanted to ask what
7	did the City use or what did HR use for the Police
8	Chief? How did they do that?
9	MS. DICKERSON: Regarding the Police Chief
10	position, it initiated prior to my arrival. But for
11	that position, internal to the City, there was a
12	selection committee. And when I came on board, I
13	was I developed the interview questions, and we
14	facilitated the process as a team.
15	It's my understanding though, and I don't
16	know if Eureka can speak to prior involvement with the
17	CRA that's the part that I don't know but for the
18	Police Chief, there was a selection committee prior to
19	my arrival, and then I participated at the point when I
20	arrived, which was the interview process. Eureka
21	can
22	COMMISSIONER LANIER: So I just want to ask,
23	so was it HR that did the search or not?
24	MS. DICKERSON: Eureka, are you able to speak
25	to that?

- I don't believe that HR performed the search.
- 2 I believe it was handled out of the City Manager's
- 3 Office.
- 4 COMMISSIONER LANIER: Okay. So if we did the
- 5 search out of the City Manager's Office, then we -- in
- 6 terms of trying to save money, you know, spending 25,
- 7 \$30,000 for a national search, I think that we should
- 8 look to what we did for the Police Chief.
- 9 VICE CHAIR LAWSON: I'm sorry, guys.
- 10 Commissioner Lanier is going in and out. I can't
- 11 really understand what she's saying.
- 12 COMMISSIONER LANIER: Okay, let me get my
- 13 earphones then.
- 14 VICE CHAIR LAWSON: Okay, thank you.
- 15 COMMISSIONER MILLER-ANDERSON: Madam Chair,
- 16 while she's doing that, I believe Mr. Evans -- can you
- 17 hear me?
- 18 CHAIR BOTEL: Yes, I can hear you. I could
- 19 hear Shirley okay. Could you hear Shirley?
- 20 COMMISSIONER MILLER-ANDERSON: She's getting
- 21 her -- yes, she's getting her earplugs. I heard her.
- 22 She's putting it in.
- 23 CHAIR BOTEL: Doug, can you check your audio,
- 24 because I could hear Shirley fine.
- 25 COMMISSIONER MILLER-ANDERSON: You can't hear

Page 10 1 me? 2 CHAIR BOTEL: I can hear you. 3 Doug. Can you hear me, Doug? Doug's having trouble. Doug couldn't hear Shirley, and I just want 4 5 to be sure he can hear going forward. 6 COMMISSIONER MILLER-ANDERSON: 7 CHAIR BOTEL: I could hear Shirley fine. 8 COMMISSIONER MILLER-ANDERSON: He's on mute 9 now though, Doug is. 10 CHAIR BOTEL: Well, that's okay. Go ahead, Ms. Miller-Anderson. 11 12 COMMISSIONER MILLER-ANDERSON: I believe 13 Mr. Jonathan Evans kind of handled the Police Chief 14 whole dynamics. So if we were to go that route, we 15 might want to check with him and see how he set that 16 up, if we could go that route internally. 17 CHAIR BOTEL: Do you have any other 18 questions? 19 COMMISSIONER LANIER: No, I was just -- you 20 know, and for the sake of expediency, for the sake of, 21 you know, not spending, you know, 20, 30, \$40,000 for a 22 search, you know, why not use the same process that we 23 used for our Police Chief? I mean that's one option. 24 CHAIR BOTEL: Thank you. 25 Mr. Lawson, did you have a question or a

Page 11 1 comment? I don't think he can hear. Doug. He can't hear. Doug. He can't hear. 2 3 MR. HAYGOOD: At some point --4 CHAIR BOTEL: Go ahead, Mr. Haygood. 5 MR. HAYGOOD: At some point I think the Board 6 should approve not a scope of services, but exactly what you're looking for in a Director, years of 7 service, familiarity with the CRA statute or any other 9 things that you would think would be needed in a --10 would be needed in your new Director. 11 And then if you want to follow that, we could 12 then give you some publications that you would 13 advertise in and then come up with a process of how 14 you're going to review the candidates and come up with 15 a -- how you're going to make a selection, whether 16 you're going to actually, you know, narrow it down to 17 five people, where you're going do an interview process 18 and so forth. 19 CHAIR BOTEL: Thank you, Mr. Haygood. 20 Yes, go ahead, Ms. Lanier. COMMISSIONER LANIER: Yes, I just wanted to 21 22 say that, you know, at this point, you know, this is 23 the first step of the process. We're just trying to 24 figure out how we're going to move forward. So I think 25 the first step that we need to do is figure out what

- 1 the actual process is. Do we use a headhunter, or do
- 2 we pay a consulting firm to do a national search, do we
- 3 do it locally, do we do it through the City Manager's
- 4 Office? I mean what is the -- we need to figure out
- 5 what that process is before we start talking about how
- 6 many candidates and that kind of thing.
- 7 CHAIR BOTEL: Right, I agree. And what I'm
- 8 hearing from you -- correct me if I'm wrong,
- 9 Ms. Lanier -- is that you are reluctant to spend 25 or
- 10 \$30,000 on this, and if I hear you correctly, you're
- 11 saying that your preference would be to do it
- 12 internally first and let the process come out of the
- 13 City Manager's Office. Is that correct?
- 14 COMMISSIONER LANIER: Well, yes, and at least
- 15 give us something to start with. You know, we see
- 16 something from the City Manager's Office or internally
- 17 that we wanted to change, or if we see it and we say
- 18 no, we should go out for a national search, at least it
- 19 gives us a starting point.
- 20 CHAIR BOTEL: And Mr. Haygood, I'm
- 21 thinking -- and Ms. Dickerson, if you're listening as
- 22 well, I'm thinking that perhaps what you suggested
- 23 could be accomplished first by our HR Department, to
- 24 give us a straw man to work with, something that you
- 25 would suggest from HR that could give us a starting

Page 13 1 point in terms of a direction, a description of the job 2 and so on, that that would be much appreciated, I would think. 4 Mr. McCoy, did you have a comment? 5 COMMISSIONER McCOY: Yes, I did. Can you 6 hear me? 7 CHAIR BOTEL: Yes. 8 COMMISSIONER McCOY: Okay, I wanted to 9 suggest a search firm, because that's what we've used in the past. And our Manager, Mr. Evans, and even 10 11 prior to Mr. Evans, Ms. Jones, as well as our previous 12 CRA Director were all recruited by a search firm. 13 And I'm concerned because we have to first 14 establish what kind of qualifications that we're looking for. I mean be it locally, in our own HR, or 15 16 nationally, I don't want anybody to make the decision 17 for me. If I'm stuck having to actually make a 18 decision on hiring somebody, it should be based on the criteria that we set as a Commission and not something 19 20 that, you know, the search firm just goes out 21 arbitrarily and says what's best for the City. 22 I mean so certainly I would think if we 23 established a criteria, but I'm certainly leaning 24 toward a search firm. That way we can complete -- keep 25 it completely separate from the City, because the first

- 1 thing I noticed was the Manager was not the personnel
- 2 responsible for receiving the applications and sorting
- 3 through those applications. So certainly that was done
- 4 at the HR level.
- 5 So perhaps Ms. Dickerson was not aware, but I
- 6 know certainly I had already seen that the position was
- 7 advertised, and it was being held through our Police
- 8 Department. And at one point, I remember hearing
- 9 somewhere over 50 applications.
- 10 So certainly I know the Manager didn't have
- 11 the responsibility of going through as the first round
- 12 of screening out all of those Police Chief candidates.
- 13 So I would certainly like to see that we establish a
- 14 criteria and then rely on someone that specializes in
- 15 solely recruiting of executive positions.
- 16 CHAIR BOTEL: Mr. McCoy, you'd rather not
- 17 have our HR Department lead it, you'd rather have a
- 18 search firm, and it's okay with you if we spend money?
- 19 Just asking.
- 20 COMMISSIONER McCOY: I mean I think the money
- 21 is immaterial. We've operated without an Executive
- 22 Director, so there are dollars that are there. So it
- 23 shouldn't be necessarily a situation where we're trying
- 24 to do it on a meaning budget, like 25,000. I think
- 25 that's typical when you're searching for an Executive

Page 15 1 Director. 2 CHAIR BOTEL: Okay, thank you. 3 Mr. Lawson, can you hear us? I don't think he can hear. Mr. Lawson, can you hear us? Would you 4 5 turn your mic on. 6 VICE CHAIR LAWSON: I can hear you, but it's 7 just going in and out, so I'm not sure if I'm going to try to -- I'm going to go out and come back in. Maybe 9 it's my connection. But let me go out and come back 10 in, and then I just have two comments that I want to 11 make. 12 CHAIR BOTEL: Okay, we'll wait for you. 13 Let the record show that Mayor Felder --14 VICE CHAIR LAWSON: Thank you. 15 CHAIR BOTEL: -- has joined the meeting. 16 Ms. Miller-Anderson, did you have a 17 preference as to using a search firm or doing it 18 in-house with our own HR Office? 19 COMMISSIONER MILLER-ANDERSON: I would just, 20 you know, if we did our own in-house -- and I mean 21 Mr. McCoy was correct, I mean from the ones that I 22 participated on, they've always been a national search.

If we did the local in-house, I would need to know

exactly how we reached out to other people outside.

You know, I know the national -- the only downside to

- 1 that with sometimes with a national search is that you
- 2 have a recycling of the same people who have been
- 3 trying to get a certain position, they've been hanging
- 4 out there for a while, so you do have to kind of think
- 5 about that.
- 6 But I would suggest that we try to, first of
- 7 all, identify what the scope of work, what the job
- 8 description is going to be. And then we can determine,
- 9 you know, if that is something that we want to do based
- 10 on, you know, do we have the talent right here in Palm
- 11 Beach County, do we know if there's some people in the
- 12 state of Florida. We may not even find anyone here in
- 13 the state of Florida; it may be out. And I think if we
- 14 go outside of the state, you may look into having to
- 15 have a national reach, and that's where that search
- 16 firm would come in.
- I think that, one, I don't think we need to
- 18 concern ourselves with the money, like Mr. McCoy said.
- 19 I mean 20, 30,000 is typically what it is. But if we
- 20 want to get a -- cast our net pretty wide, I would
- 21 think the national search would be the way. However,
- 22 if we spoke with not going through the City to do it,
- 23 but surely, you know, hopefully someone in the HR could
- 24 handle that process, and if not, then a national search
- 25 would probably be the way to go --

1	CHAIR BOTEL: So it sounds to me like
2	COMMISSIONER MILLER-ANDERSON: although
3	the applications do come in, you know, even when we did
4	the national search, they came in through HR. But they
5	weren't heavily involved as the search firm was.
6	CHAIR BOTEL: I think we might all agree that
7	the first step, even before we decide how we want to do
8	it, is for the HR Department to develop something for
9	us to look at in terms of a job description and
10	necessity qualifications. And once we have that, we
11	can make our changes and modifications to it, and then
12	we have to decide whether or not we're going to do it
13	with a search firm or first with our HR.
14	Mr. McCoy.
15	COMMISSIONER McCOY: Thank you, Madam Chair.
16	So Mr. Haygood and Mr. Scott Evans, were we
17	able to come up with anything on how this process was
18	done in the past as far as language and what that, I
19	guess, baseline criteria that was used in the past when
20	we last recruited an Executive Director for the CRA?
21	MR. HAYGOOD: I have not quoted yet. I don't
22	remember, to be honest with you, whether it was done by
23	a maybe Scott might whether it was done by a
24	search firm or whether HR did it. I don't recall.
25	INTERIM EXECUTIVE DIRECTOR EVANS: My

- 1 recollection is we advertised it in multiple places,
- 2 and then received the applications, and then had the --
- 3 I think the Commission went through, selected their top
- 4 ranked ones, and then they made a choice when they got
- 5 it narrowed down about, I want to say maybe five or
- 6 six. Then they started an interview process with the
- 7 selected.
- 8 CHAIR BOTEL: So it sounds like you didn't
- 9 use a search firm. You advertised widely and did it
- 10 in-house.
- 11 INTERIM EXECUTIVE DIRECTOR EVANS: I'd have
- 12 to research it, but I believe that was the case.
- 13 COMMISSIONER LANIER: Madam Chair.
- 14 CHAIR BOTEL: Yes, Ms. Lanier.
- 15 COMMISSIONER LANIER: I just also wanted to
- 16 say that we also need to, when we're talking about
- 17 scope of service -- let me see my phone a second.
- MR. HAYGOOD: All right --
- 19 COMMISSIONER LANIER: When we talk about --
- 20 that's okay. When we talk about scope of service, we
- 21 also need to talk about the makeup of the CRA. There
- 22 are a lot of CRAs across the state that work closely in
- 23 conjunction with the City.
- We're going to look at, you know, especially
- 25 in the whole framework -- and I say this all the

- 1 time -- in the whole framework of COVID-19. We need to
- 2 be realistic about the next few years and how we're
- 3 going to move forward in terms of saving money, in
- 4 terms of how we look at the CRA structure and the City
- 5 structure and how either we can combine those or that
- 6 we can make sure that we're getting the most bang for
- 7 our buck for this whole -- because it is a part of the
- 8 City.
- 9 CHAIR BOTEL: Thank you.
- 10 COMMISSIONER LANIER: I just want to put that
- 11 out there in terms of scope of service.
- 12 CHAIR BOTEL: I'm glad you did. It sounds
- 13 like perhaps we want not only a description of the job
- 14 from HR, but also potentially how the structure could
- 15 look and if they could provide us with a couple of
- 16 different options.
- So for example, does the CRA become a
- 18 department of the City? Does the CRA -- you know, how
- 19 does that interrelationship work? I think it would be
- 20 good for us, as you say, Ms. Lanier, to have a
- 21 discussion, a conversation. And I think that
- 22 conversation should be we'll have that with the City --
- MS. YOUNG: Hello?
- 24 CHAIR BOTEL: Who's there?
- MS. YOUNG: This is -- I'm sorry to

Page 20 1 interrupt. This is Eureka, the HR Department. I know 2 prior, the HR Department was not involved in the selection of the CRA Director. And so if there is -if HR wasn't being involved (inaudible) --4 5 COMMISSIONER LANIER: Madam Chair. 6 CHAIR BOTEL: Cutting out a little. MS. YOUNG: What happened? 8 CHAIR BOTEL: Right, let me just finish. 9 Eureka, let me just finish what I was saying. 10 So in addition to providing --11 MS. YOUNG: Can you hear me? 12 CHAIR BOTEL: Yes, but can you hold one 13 second, please? We heard you say that HR was not 14 involved in the search process. 15 What I was saying was based on what 16 Ms. Lanier was saying with regard to not only should we 17 look at a job description, we also might want to look 18 at the organization itself to see does it serve us 19 better as a community to have the CRA come under the 20 City, or what is the relationship between the CRA and 21 the City, are there any cost benefits to combining 22 certain things. 23 So I'm thinking that perhaps Mr. Evans and 24 the HR Department could provide us with some examples 25 for us to look at of where the CRA, in other cases, in

- 1 other cities where the CRA is, in fact, a part of the
- 2 city so that we can begin to have a discussion about
- 3 that. And I think we should have that discussion
- 4 (inaudible) possible. Could we have that within, the
- 5 next, say, 30 days, even two weeks? It shouldn't take
- 6 long to do it.
- 7 And what I mean by that is not only a job
- 8 description if we were to go out either with a --
- 9 depending on -- it doesn't matter how we do it. If we
- 10 were to go out with a search firm or if we were to
- 11 allow the City to do it for us, the HR Department of
- 12 the City to do it for us, in either case we need a good
- job description, we need a set of qualifications that
- 14 we want for that person. And in addition to that, we'd
- 15 like to have some examples of other ways the CRA and
- 16 City relationship could be structured.
- Does that make sense to everybody? And I'll
- 18 go alphabetically.
- Ms. Lanier, does that make sense to you?
- 20 COMMISSIONER LANIER: Yes, it makes perfect
- 21 sense to me. As I said before, you know, framing
- 22 everything in COVID-19, framing everything with, you
- 23 know, what for sure is going to be a recession, framing
- 24 everything in terms of trying to keep people safe and
- 25 how you're going to -- every city, every municipality

- 1 now is talking about cutting costs and how we're going
- 2 to go down this road in terms of trying to consolidate
- 3 services, trying to move forward whole. So yes, I
- 4 agree with that.
- 5 And I also agree with the fact that I do have
- 6 some models that are from across the state, from City
- 7 of Jacksonville, City of Palatka, City of Northwest
- 8 Miami that has a consolidation, but it's like a hybrid.
- 9 It's not really a consolidation, but it's a hybrid of
- 10 the City and the CRA doing business together. So there
- 11 are different models that are out there that are in the
- 12 state, they're in south Florida, that operate the same
- 13 way, so that if we can get an idea of how the person
- 14 who's going to run the CRA is going to do it, we also
- 15 need to have an idea of how the CRA itself is going to
- 16 be presented.
- 17 CHAIR BOTEL: You'll share that information
- 18 with HR.
- 19 And Mr. Haygood has a question.
- MR. HAYGOOD: No, while we were talking,
- 21 Tamara sent me the advertisement for the position that
- 22 was sent out in 2009, which includes educational
- 23 requirements, examples of work and so forth. So we'll
- 24 share that with the Board.
- 25 CHAIR BOTEL: Thank you.

Page 23 1 So back to Ms. Lanier. You'll share that 2 information you have with -- let's run everything through the HR Department so as not to --4 COMMISSIONER MILLER-ANDERSON: Madam Chair. VICE CHAIR LAWSON: Madam Chair. 5 6 CHAIR BOTEL: Miller-Anderson first, and then Mr. Lawson. 7 8 COMMISSIONER MILLER-ANDERSON: I know Lawson wanted to make his comments, but I just wanted to point 9 10 out about the announcement about how the public can 11 comment, provide their comments. 12 CHAIR BOTEL: Yes, thank you. I'll read 13 that. I'll read it for the next -- public doesn't 14 comment in a workshop, right? 15 COMMISSIONER MILLER-ANDERSON: You're right, 16 you're right. I'm so sorry, yes; yes, you're right. 17 CHAIR BOTEL: The next meeting, okay, thank 18 you. Did you have a comment about this while I have 19 you with regard to --20 COMMISSIONER MILLER-ANDERSON: No, no, no. I 21 was thinking this was an agenda item. No. 22 CHAIR BOTEL: Mr. Lawson. 23 VICE CHAIR LAWSON: Thank you, Madam Chair. 24 All right, so kind of recapping, and I was 25 hearing only bits and pieces of the conversation, but

- 1 from my notes and what I see with our national
- 2 searches, I would actually prefer that a national
- 3 search firm develops that scope of work, because if
- 4 we're truly looking for the best and the brightest
- 5 across the nation to come to our City and to be the
- 6 Director of our CRA, I want us to have a broad scope,
- 7 not just based upon what we used in the past, but also
- 8 be a little bit more transparent with what the
- 9 residents want to hear.
- 10 So we provide information to the national
- 11 search firm to allow for them to know what we're
- 12 looking for, what we want to establish, in addition to
- 13 actually working with our County and seeing what
- 14 they've done. And we could possibly piggyback on all
- 15 these searches that they've done as well, and then
- 16 having a national search firm develop the entire scope
- 17 of work.
- Right now my concern with HR is that the last
- 19 post that I've seen from HR was back in March 6th for
- 20 job descriptions. And they normally were posting every
- 21 week. HR is currently flooded with work. We have
- 22 seven executive positions currently being advertised on
- 23 the HR City side. So I don't want to add additional
- 24 work when our CRA and our City -- even though we want
- 25 them working in a cohesive manner, we're still separate

Page 25 1 entities, so I want to make sure that we keep it 2 transparent and keep them separate. 3 CHAIR BOTEL: Thank you, Mr. Lawson. Mr. McCoy, did you have --4 5 COMMISSIONER McCOY: (Inaudible.) 6 CHAIR BOTEL: Please, you're muted. I know 7 that's hard for you, to be muted, but --COMMISSIONER McCOY: Yes, Madam Chair. 8 9 So I'm not sure why we are at the 10 conversation of speaking of operations. I think we 11 started this two weeks ago and we had the conversation. 12 These are two mutually exclusive things. The CRA 13 Director and the operations are something totally 14 different. 15 As it stands, just from the current structure 16 of the CRA, it reports to the Board. So about 17 consolidating operations, that's a whole different 18 conversation that I don't think is even germane to this 19 topic. And I think when you start talking about 20 structures, at this point I mean I think we should 21 address it from the City side. 22 If you're really concerned that the 23 operations are better suited as a department within the 24 City, then that shouldn't be a part of this discussion, 25 I mean because we started off talking about the

- 1 process, but, you know, I'm really -- and I'll share
- 2 this with you.
- I was the one that brought the item before
- 4 from the special meeting agenda, and Madam Chair and
- 5 Commissioner Lanier, you guys were very much against us
- 6 even having the conversation. But I definitely wanted
- 7 us to at least explore the options, but definitely not
- 8 the options of trying to do some conglomerate move to
- 9 both look to hire a CRA Director and also to, I guess,
- 10 streamline operations. I think that's a little bit
- 11 much to bite off, especially being that we're in this
- 12 current situation. And currently the Manager is
- operating under EOC. And I don't want this process to
- 14 become another priority in the City, meaning from the
- 15 City side.
- You know, it was my idea that we can go back
- out, and I started the conversation by asking, you
- 18 know, what was the plan and was there any kind of
- 19 performance evals done, which kind of led me to believe
- 20 that this wasn't a permanent position for Mr. Evans,
- 21 Mr. Scott Evans, and that's why we needed to start the
- 22 conversation. It was not my desire for us to
- 23 restructure the organization. I think we have to
- 24 really take one step at a time. And before we do that,
- 25 I think the most important thing is establishing the

- 1 criteria.
- 2 And I really am disappointed, Mr. Haygood and
- 3 Mr. Evans, that two weeks ago I was hoping that we were
- 4 coming back to have these same items provided to us.
- 5 And I was very clear when I asked Commissioner Lanier
- 6 if she could clarify what those models meant. And I
- 7 asked the question as what should we expect when we get
- 8 here today. And if we're here today and we're still
- 9 talking about we're going to go back and look, it seems
- 10 like we just wasted two weeks of what could have been
- 11 we being presented with options that were used in the
- 12 past, or, you know, industry trends on what it takes to
- 13 hire an executive position such as the CRA Director.
- 14 That's all I have, Madam Chair.
- 15 CHAIR BOTEL: Thank you. I was attempting to
- 16 honor Ms. Lanier's concerns, Mr. McCoy.
- And I think I would have to disagree with you
- 18 with regard to, you know, what comes first, the chicken
- 19 or the egg. If we do eventually decide that the CRA
- 20 would come under the umbrella of the City, I would
- 21 think that the qualifications of whomever that person
- 22 at helm would be might be somewhat different than an
- 23 Executive Director of a stand-alone CRA, which is why I
- 24 think if we are going to have that conversation about
- 25 changing the structure of the organization, that's the

Page 28 1 conversation that has to happen first. 2 How do you all feel about that? 3 VICE CHAIR LAWSON: Madam Chair. COMMISSIONER LANIER: Madam Chair. 4 VICE CHAIR LAWSON: Madam Chair. 5 6 CHAIR BOTEL: First Ms. Lanier, and then 7 Mr. Lawson. COMMISSIONER LANIER: I think that I don't 8 9 want to get off track here. And I certainly understand Mr. McCoy's position that we came here to talk about a 10 11 CRA Director, and as he said, you know, we were 12 supposedly to look at some, you know, job criteria, you 13 know, what were we looking for, we could add this, we 14 could take away that. That's what I was thinking that 15 would happen tonight. But as we are -- that was two, 16 you know, two weeks ago. 17 When we're looking down the barrel of this, 18 and I keep saying this COVID-19 issue, it's not going away. And if we're going to be talking about moving 19 20 the City forward and we're going to be talking about 21 huge development projects, we're going to be talking 22 about trying to streamline and save and cut corners and 23 cut costs in terms of how we're going to move forward 24 with the City, the CRA is a part of the City. So it's 25 not mutually exclusive. They go hand in hand.

- 1 If we -- you know, there are different models
- 2 out there that have hybrid. It doesn't have to be one
- 3 or the other. It can be a hybrid situation, the same
- 4 way our City Council is a hybrid. We have a small --
- 5 we have a Mayor on this Council that does not vote.
- 6 Some cities have a Mayor on the Council that does vote.
- 7 So there are different hybrids of how we can move this
- 8 forward.
- 9 But we also have to talk about this
- 10 simultaneously, because we're trying to make sure that
- 11 we're using the money that we do have in the best
- 12 interest of the City. So I think that we can talk
- about both at the same time, we can have discussions
- 14 about both of them at the same time.
- But as for Mr. McCoy's point, first let us
- 16 look at what are we looking for in a CRA Director, and
- 17 at the same time, how are we going to look at our CRA
- 18 and how are we going to try and streamline our services
- 19 at the CRA side, at the City side, at the Utility
- 20 District side.
- 21 We sit on three Boards, three Boards. So we
- 22 have to be able to understand that going forward, we're
- 23 going to have to look at how we're going to streamline
- 24 some of these services, because it is not going to be
- 25 the same as usual. And I just say that because at

- 1 least we can have a discussion about it. We're not
- 2 making a decision tonight. We're just having some
- 3 discussion, we're looking at different options. I
- 4 think those should be on the table.
- 5 CHAIR BOTEL: Thank you.
- 6 Mr. Lawson.
- 7 VICE CHAIR LAWSON: Thank you, Madam Chair.
- 8 And thank you for your comments, Ms. Lanier.
- 9 I agree with you in regards to we can do both, we can
- 10 have the conversation. But I also agree that tonight's
- 11 topic is about hiring the Executive Director. And like
- 12 Councilman McCoy, I'm a little disappointed, because I
- 13 wanted some additional information so that we could
- 14 make a decision tonight to move forward.
- Mr. Evans, I have a question. What is
- 16 currently your spending limit as a CRA Director?
- 17 INTERIM EXECUTIVE DIRECTOR EVANS: 25,000.
- 18 VICE CHAIR LAWSON: Okay. And Mr. Haygood,
- in the event that we selected a national search firm
- 20 that was 25,000 or less, would that allow for us to
- 21 avoid having to go through the RFP process?
- MR. HAYGOOD: Yes. But what I would suggest
- 23 is that you do an informal, get quotes from three
- 24 firms, identify three firms and get quotes.
- 25 VICE CHAIR LAWSON: Absolutely. I would

- 1 definitely recommend that so that the RFP process
- 2 doesn't have to lengthen what we're trying to go
- 3 through with bringing in a national firm. But again,
- 4 that would be my recommendation, just to allow for the
- 5 national firm to come in and to develop that scope and
- 6 to do the work.
- 7 And I do agree with Councilman Lanier that we
- 8 have to be frugal with our spending. But we also have
- 9 to make sure we bring in the best candidate, because
- 10 we're looking to have a CRA Director that's going to be
- 11 here for 10, 15, 20 years. So if we can bring that in
- 12 and allow us to get the right hire, get the right
- 13 person that's going to work cohesively with the City, I
- 14 think we need to just look on the national level.
- 15 Thank you, Madam Chair.
- 16 CHAIR BOTEL: Thank you. Anyone else?
- 17 All right, the sense I'm getting is that this
- 18 committee -- it's a Board, right?
- 19 COMMISSIONER MILLER-ANDERSON: Commission.
- 20 CHAIR BOTEL: Commission. And you're right,
- 21 Ms. Lanier, we have a Board, a Commission and a
- 22 Council.
- This Commission wants to go forward and do a
- 24 national search -- correct me if I'm wrong, anyone --
- 25 and at the same time, we want to take a look at the

- 1 structure of the CRA to see whether or not we can have
- 2 any cost savings because of things that we might do
- 3 with the City. And in order to accomplish that, we'd
- 4 probably need a workshop where the City is involved,
- 5 you know, so that we can have this conversation with
- 6 both Messrs Evans in the room. Have I got that right,
- 7 everyone?
- 8 COMMISSIONER LANIER: Yes. Madam Chair, and
- 9 I would just add that if you want to, if the Board
- 10 wants to move forward with a national search, then
- 11 that's fine. But I still say it's a waste of money
- 12 when we have people internally who can do that. But if
- 13 that's where the Board wants to go, then that's fine
- 14 with me.
- 15 CHAIR BOTEL: Now, maybe it's not fine with
- 16 you. Ms. Miller-Anderson, did you want to say
- 17 something?
- 18 COMMISSIONER MILLER-ANDERSON: Well, you
- 19 know, it just reminded me this is a workshop, so we
- 20 can't make that total decision to (inaudible), but we
- 21 can bring it back maybe during the meeting to vote on
- 22 if that's what (inaudible) over two options, and then
- 23 we vote on which way we're going to go from there.
- 24 CHAIR BOTEL: So we'll bring it up --
- 25 COMMISSIONER MILLER-ANDERSON: But you would

- 1 have more information, because Mr. McCoy, you're still
- 2 wanting information, or you just want to go straight
- 3 with the national search?
- 4 CHAIR BOTEL: Mr. McCoy.
- 5 COMMISSIONER McCOY: I would like to see,
- 6 Mr. Haygood, is it possible for us to have whatever
- 7 information you received about the criteria that you
- 8 received during the meeting sent to us right now, and
- 9 then --
- 10 MR. HAYGOOD: Certainly. I'll e-mail it to
- 11 you now; I'll try to e-mail it to you now. If for some
- 12 reason my skills aren't that good, we certainly will
- 13 get it to you no later than after the meeting I'll send
- 14 it out.
- 15 COMMISSIONER MILLER-ANDERSON: Everybody
- 16 needs to have it.
- MR. HAYGOOD: Yes.
- 18 CHAIR BOTEL: I'm a little concerned about
- 19 getting information, you know, it's 6:38, and then
- 20 trying to act on it in some way at our meeting. I
- 21 would prefer to have the information and at least have
- 22 a day or so to digest it myself. You all feel --
- MR. HAYGOOD: I wasn't suggesting that you do
- 24 that in order to vote on it this evening.
- 25 CHAIR BOTEL: I think Mr. --

- 1 MR. HAYGOOD: My suggestion would be that you
- 2 bring it back to your regular meeting. We'll circulate
- 3 the information we have from the last meeting and bring
- 4 you back quotes from three firms. Either we can -- I
- 5 would think that you'd want to be involved in that
- 6 decision on hiring the search firm.
- 7 CHAIR BOTEL: We would.
- 8 MR. HAYGOOD: So we'll bring that to you at
- 9 the next meeting and a proposed scope of services or
- 10 job description.
- 11 CHAIR BOTEL: Yes, I sense an urgency on the
- 12 part of Mr. McCoy, at least, in that he is already not
- 13 happy about the fact that he didn't have that
- 14 information for this evening's meeting. So my sense is
- 15 that perhaps we might want to have a workshop with the
- 16 City and combine a workshop with the City where we
- 17 discuss the structure of the CRA as it relates to the
- 18 City, and at the same time in that meeting that would
- 19 happen prior to whatever next month, May's meeting
- 20 would be so that we don't drag this on for another
- 21 month.
- 22 Am I right, Mr. McCoy?
- COMMISSIONER McCOY: You're wrong, Madam
- 24 Chair.
- 25 CHAIR BOTEL: Then correct me, please.

Page 35 1 COMMISSIONER McCOY: Wow. Would you say that 2 again? I just want -- ask me again. 3 CHAIR BOTEL: He doesn't want to say I was right. 4 5 COMMISSIONER McCOY: You're wrong, Madam 6 Chair, respectfully. 7 No, actually, so I really was concerned, 8 Mr. Haygood, so does this criteria speak to who the search firm was, because it seems like we're taking 9 10 baby steps. I don't want us to go back and have 11 another meeting to find out then we need to select 12 three more firms. Is there any indication from the information 13 14 that you have from Ms. Tamara who one of those search 15 firms are? Are we going to identify criteria of, you 16 know, I mean just through -- I don't know if it's just 17 a Google search on some of the top executive search 18 firms, but I don't want us to get back here again and 19 figure out we should have had a discussion about who 20 those top three firms are, because we're not going 21 out -- I don't think this is something to go out for 22 bid for. Who would go out and bid on something like 23 this? We really get what we pay for when it comes it a 24 search firm. 25 So I want to know that we have some plan to

- 1 address who those top three are, those top three search
- 2 firms. And this is separate and independent of
- 3 whatever other substantive discussion you want to have
- 4 about CRA and City operations.
- 5 MR. HAYGOOD: Well, again, there was not a
- 6 search done the last -- when we hired the last
- 7 Executive Director, we didn't use a search firm, so we
- 8 don't have information on a search firm. What we do
- 9 have is, and if you -- I don't know if you want
- 10 Mr. Evans to choose a firm. That's the only way I know
- 11 we could do it without bringing it back to you.
- 12 CHAIR BOTEL: Ms. Miller-Anderson.
- 13 COMMISSIONER MILLER-ANDERSON: I mean we can
- 14 get with HR to get some of the search firms that we've
- 15 used over the past. We've used them for City Manager a
- 16 couple times, if I'm not mistaken, at least I think
- 17 twice maybe. And so we can -- they should have some
- 18 contacts that they've used before, and then we can --
- 19 you can have those. I don't think Mr. Scott Evans
- 20 should be the one deciding on what search firm to use.
- If we're not having another meeting for
- 22 another month, maybe we need to have one sooner. I
- 23 mean nothing is stopping us from having another CRA
- 24 meeting sooner. We can do that so that we don't have
- 25 this lapse in time. But I mean the information does

- 1 have to come to us so we can see it and discuss it and
- 2 vote on it. So if we need to have a special meeting,
- 3 then we need to have a special meeting. It doesn't
- 4 have to be long. But we don't need to wait a whole
- 5 month. And we definitely need to meet before we, you
- 6 know, can have a search firm.
- 7 So getting with HR, I mean, Mr. Haygood,
- 8 contact a few other -- contact Florida League of
- 9 Cities, I mean a number of places that you all can do
- 10 research on and find these people, because the search
- 11 firms are out there. That's not hard to find. But
- 12 those that we've used in the past, we can certainly at
- 13 least start there and get those names from HR who we
- 14 used in the past. And Ms. Eureka was there, so she
- 15 definitely knows who they are.
- 16 That's it. Thank you, Madam Chair.
- 17 CHAIR BOTEL: Mr. Haygood, can you go ahead
- 18 and get some information for us, and let's set a
- 19 meeting for, I would say two weeks?
- MR. HAYGOOD: Yes, ma'am. But I want to know
- 21 exactly what you want. You know, you all weren't very
- 22 specific last time as to what you were looking for, so
- 23 if you can, be specific as to what you want me to do.
- 24 I know you want me to bring back, as I understand it --
- 25 let me summarize. You want me to bring back three

- 1 firms, at least three firms, and bring back quotes from
- 2 those three firms as to the search. We would also have
- 3 on that agenda the scope of services and education and
- 4 other qualifications you'd be looking for in an
- 5 Executive Director.
- 6 CHAIR BOTEL: Yes.
- 7 MR. HAYGOOD: Okay, I understand.
- 8 CHAIR BOTEL: Is there anyone else that
- 9 Mr. Haygood should be asking?
- 10 COMMISSIONER LANIER: Well --
- 11 CHAIR BOTEL: Go ahead, Ms. Lanier.
- 12 COMMISSIONER LANIER: Well, now, I was just
- 13 going to say that, you know, we're looking for HR to
- 14 lay out this process. You know, and we have the CRA to
- 15 lay it out or we have the City to lay it out.
- Now, I was thinking that the HR Department,
- 17 who is well-versed in this area, I mean, that's what
- 18 they do. They, you know, I'm sure that they have, as
- 19 Miller-Anderson, Councilwoman Miller-Anderson has
- 20 suggested, that they have, you know, numerous search
- 21 firms that they can bring back to us to be able to
- 22 choose and make that decision. And (inaudible) with
- 23 us, and not with, you know, anybody else.
- 24 CHAIR BOTEL: Thank you.
- Mr. Haygood, would you please work with

- 1 Ms. Dickerson on that and bring back -- would you
- 2 please work with Ms. Dickerson on that.
- And Ms. Dickerson, would you please be at the
- 4 meeting in two weeks and be able to have -- answer any
- 5 questions we might have.
- And Mr. Evans can set a meeting for us for
- 7 two weeks hence.
- 8 Does that satisfy everyone?
- 9 COMMISSIONER LANIER: Yes, ma'am.
- 10 CHAIR BOTEL: Is there anything else for this
- 11 workshop?
- 12 COMMISSIONER McCOY: Question. So two weeks
- 13 puts us at the 6th, and I believe we have a City
- 14 Council meeting that date.
- 15 COMMISSIONER LANIER: We can do it the day
- 16 after or the day before.
- 17 INTERIM EXECUTIVE DIRECTOR EVANS: If I could
- 18 just add, if you want to wait to the date of the 13th,
- 19 that would be our regular CRA meeting, and I would like
- 20 to have some COVID related new items ready for that.
- 21 So I would just offer that the 13th might be a good
- 22 date to both do that and for me to bring back some
- 23 potential COVID related examples.
- 24 COMMISSIONER LANIER: Well, that sounds --
- 25 I'm sorry, Madam Chair.

Page 40 1 CHAIR BOTEL: Ms. Miller-Anderson raised her 2 hand, like a good student. 3 COMMISSIONER LANIER: Oh, oh. CHAIR BOTEL: So she can go ahead. 4 5 COMMISSIONER MILLER-ANDERSON: That's right, 6 you're right. 7 COMMISSIONER LANIER: The teachers, okay, I 8 see now; I see now. COMMISSIONER MILLER-ANDERSON: We have 9 structure here. No, she can go ahead. 10 11 CHAIR BOTEL: Go ahead, Ms. Lanier. 12 COMMISSIONER LANIER: No, I was just going to 13 ask that I don't -- you know, and the workshop and this 14 meeting came at the same day. I don't like a workshop 15 and a meeting at the same time, on the same day, 16 because you may get into -- you know, a lot of times, 17 and people, you know, we know we get into the weeds a 18 lot with a lot of these issues. 19 So I don't want to have a workshop and we 20 start talking about an issue and then it runs over, and 21 then, you know, we're here to 10, 11:00 at night with, 22 you know, another meeting. I think that these two 23 meetings should be separate and that, you know, I mean 24 it's only 6:44, so it should only be, you know, an hour 25 or so, or an hour and a half at the most to be able to

- 1 have a conversation about this.
- 2 And then also, I want to add that at this
- 3 next meeting in two weeks, are we going to add the
- 4 models to that agenda item as well?
- 5 CHAIR BOTEL: I think that we should begin to
- 6 talk about that. I don't know whether we want to --
- 7 whether we would have time at that meeting to do that.
- 8 We'd have to ask --
- 9 COMMISSIONER LANIER: Well, if it's on a
- 10 separate -- I'm sorry; I'm so sorry. If it's on a
- 11 separate date, we could.
- 12 CHAIR BOTEL: True. How is the 7th for
- 13 everyone?
- Ms. Miller-Anderson.
- 15 COMMISSIONER MILLER-ANDERSON: So were we
- scheduled to have a regular meeting on the 13th,
- 17 because we haven't been meeting every two weeks
- 18 recently, lately. Are we scheduled, Scott?
- 19 CHAIR BOTEL: Yes, it's on my --
- 20 INTERIM EXECUTIVE DIRECTOR EVANS: Yes, we
- 21 can have a regular meeting on the 13th. I hadn't put
- 22 out the May schedule yet due to the COVID restrictions,
- 23 but we can have a meeting on then.
- 24 COMMISSIONER MILLER-ANDERSON: So we would be
- 25 having a workshop and a meeting, or would you just be

- 1 having the workshop, and the regular meeting the
- 2 following, the fourth --
- 3 INTERIM EXECUTIVE DIRECTOR EVANS: Just
- 4 following the conversation, it seemed like the Board
- 5 wanted to make a decision on this at the next meeting,
- 6 so --
- 7 COMMISSIONER MILLER-ANDERSON: Okay, but I'm
- 8 saying it wasn't a regular agenda? I mean did you have
- 9 a regular agenda with other items, or was it just going
- 10 to be a meeting?
- 11 INTERIM EXECUTIVE DIRECTOR EVANS: Yes, I
- 12 would like to have some special COVID items that I
- 13 would like to bring on the 13th.
- 14 COMMISSIONER MILLER-ANDERSON: I'm fine with
- 15 it being on that day, I mean as long as the agenda is
- 16 not long. I don't know, with the workshop and then --
- 17 INTERIM EXECUTIVE DIRECTOR EVANS: I'm sorry,
- 18 does the Board need a workshop? Can you just -- it
- 19 could just be a regular agenda item where you review
- 20 the job description, take a proposal that you like from
- 21 one of the firms and direct us to issue it.
- COMMISSIONER LANIER: But we're not going to
- 23 have -- sorry, Madam Chair.
- 24 CHAIR BOTEL: Mr. McCoy was first, I think,
- 25 and then Ms. Lanier.

- 1 Mr. McCoy.
- COMMISSIONER McCOY: Madam Chair, so I'm
- 3 looking at the calendar for the City. It appears that
- 4 our next City Council meeting is not until the 20th of
- 5 May. So it's not actually on the 6th. And I believe,
- 6 if I'm not mistaken, I believe we decided to go once a
- 7 month as City Council.
- 8 CHAIR BOTEL: So you think we could have this
- 9 meeting on the 6th?
- 10 COMMISSIONER McCOY: It's open. I'll say
- 11 that.
- 12 CHAIR BOTEL: Why don't we plan it for the
- 13 6th then, and then if it turns out that we have to have
- 14 a City meeting, that will have to take -- you know,
- 15 we'll speak with Mr. other Evans and see what he thinks
- 16 about having a meeting at another time. You think
- 17 that -- you're pretty sure that the 6th is open, yes,
- 18 Mr. McCoy?
- 19 COMMISSIONER McCOY: I see Doug Lawson two
- 20 times. Did he duplicate himself?
- 21 CHAIR BOTEL: Twice, okay? Get over it.
- COMMISSIONER McCOY: So Mr. Evans, is that
- 23 (inaudible) to you to move forward with whatever items
- 24 you have for two weeks from today, which would be the
- 25 6th, for us to deliberate on related to COVID?

- 1 INTERIM EXECUTIVE DIRECTOR EVANS: Certainly
- 2 I'll be ready for discussion. I don't know if I'll
- 3 have resolutions and action items, but we're working on
- 4 a couple things that we'd like to bring back to you, as
- 5 well as, which I'll talk about at the next, during our
- 6 regular meeting, participating in the Manager's
- 7 initiative. So we could get something, we'll have
- 8 something on there, yes.
- 9 CHAIR BOTEL: Okay, so we can meet on the
- 10 6th.
- 11 Ms. Lanier.
- 12 COMMISSIONER LANIER: Madam Chair, can I make
- a suggestion that we have our workshop on the 6th, and
- 14 because Mr. Evans is trying to put together the items
- 15 for the next meeting, that we have the workshop on the
- 16 6th and then have the regular meeting on the 13th?
- 17 CHAIR BOTEL: I think that's a good idea.
- 18 Anybody object to that? All right, we'll have our
- 19 workshop on the 6th, and we'll have our CRA meeting on
- 20 the 13th. Any other, anything else for this agenda,
- 21 for this -- yes, Ms. Miller-Anderson.
- COMMISSIONER MILLER-ANDERSON: So why are we
- 23 having two separate meetings?
- 24 CHAIR BOTEL: Because Ms. Lanier does not
- 25 want to have a workshop on the same evening as a

- 1 meeting. And if we have a workshop, it will only
- 2 probably be about an hour long at most, and then we'll
- 3 have that done. And because Mr. Evans will not have
- 4 the items ready by the 6th, but we can have the
- 5 workshop on the 6th about this topic, and then the
- 6 items will be ready by the 13th.
- 7 Is that right, Mr. Evans?
- 8 INTERIM EXECUTIVE DIRECTOR EVANS: (Nods
- 9 head.)
- 10 CHAIR BOTEL: Yes.
- MR. HAYGOOD: So may I ask, what is the
- 12 purpose of the workshop? I thought you were going to
- 13 take action on the items, at least selecting the search
- 14 firm, and I guess approving a scope of service or
- 15 whatever. You can't do it in your workshop.
- 16 CHAIR BOTEL: Ms. Lanier.
- 17 COMMISSIONER LANIER: Madam Chair, we were
- 18 supposed to have information tonight about making this
- 19 decision, or at least trying to move forward. So the
- 20 workshop will have us, afford us the opportunity for
- 21 you to bring all the information that we have in terms
- of scope of service, information that you have in terms
- 23 of criteria for the position, information that you have
- 24 in terms of how we're going to -- the process that's
- 25 laid out.

- 1 You know, we don't want to piecemeal this.
- 2 We want a whole process; how we're going to start with
- 3 this, how we're going to end with this. We're going to
- 4 do a national search, okay, bring a national search to
- 5 the table so that we can be able, on the 13th, to make
- 6 a final decision. But I don't want to have information
- 7 piecemeal and sent to me over the next two weeks and
- 8 then we get to the meeting on the 13th and we still
- 9 don't know what's really going on here.
- 10 So if we have a workshop on the 6th, because
- 11 as Mr. McCoy has said, that he wanted to -- you know,
- 12 he expected this information tonight. We have this
- 13 workshop on the 6th, we can move forward, we can look
- 14 at all this information. On the 13th we can make a
- 15 decision.
- 16 COMMISSIONER MILLER-ANDERSON: Madam Chair.
- 17 CHAIR BOTEL: Ms. Miller-Anderson.
- 18 COMMISSIONER MILLER-ANDERSON: I believe we
- 19 are having a meeting on the 6th for the City. I just
- 20 checked. I don't know if you have that e-mail. And
- 21 then the other thing is, you know, we could have a
- 22 discussion and deliberation on a regular agenda so we
- 23 don't have to have all of these different meetings. I
- 24 mean typically our CRA meetings don't last as long as
- 25 City meetings.

- I mean if we can get this information ahead
- 2 of time, like we should, you can have your meetings,
- 3 your agenda meetings with Mr. Haygood and Mr. Scott
- 4 Evans if you need to, or HR if there are some
- 5 additional questions that you need to get hammered out.
- 6 And then during the discussion and deliberation, which
- 7 would be a regular agenda item, if there's some
- 8 additional questions that you may have that you, you
- 9 know, may have come up with since you've had that
- 10 discussion with them, then that would be the time for
- 11 us to do it.
- 12 And it should not take long if we get all of
- 13 the information ahead of the meeting and a week in
- 14 advance. We have the discussion with the HR and
- 15 Mr. Haygood, and then we can come to our regular
- 16 meeting, have it as a discussion and deliberation item,
- 17 and if we have any other additional questions that you
- 18 may need to ask, ask it at that time, and then we could
- 19 just make the motion to go ahead and do that.
- We really don't have to have a separate
- 21 workshop per se, because that -- if we got all of that
- 22 information in advance, at least a week in advance, I
- 23 mean more than that if we can, but definitely it needs
- 24 to be posted, all of that should be posted as well a
- 25 week in advance, and that would allow us to meet with

- 1 them so we can have the one-on-one discussions, and
- 2 then we can have the -- come together during a regular
- 3 meeting. We don't necessarily have to have a workshop.
- 4 CHAIR BOTEL: It looks to me like I've been
- 5 told that we have a City meeting on the 6th. So our
- 6 only option is to allow you to get the information that
- 7 we need, present it to us well in advance of the
- 8 meeting and have our meeting on the 13th, at which time
- 9 we can take a vote. We can have the information
- 10 provided -- sorry, Ms. Lanier, that we can't have a
- 11 separate workshop, but it looks like we don't have the
- 12 time for it.
- 13 COMMISSIONER LANIER: Well, the only -- I'm
- 14 sorry. The only reason that I suggested the workshop
- 15 was the fact that we wanted to -- I wanted to have some
- 16 conversation about talking about not only the CRA
- 17 Director, but the structure of the CRA as it relates to
- 18 the City. So then I --
- 19 CHAIR BOTEL: Let's put that on the agenda as
- 20 a --
- 21 COMMISSIONER LANIER: Okay, okay.
- 22 CHAIR BOTEL: -- as two separate. But let's,
- 23 I agree, let's have both those conversations at our
- 24 meeting on the 13th.
- Ms. Miller-Anderson, and then we're going to

- 1 cut this off.
- 2 COMMISSIONER MILLER-ANDERSON: So can we give
- 3 Mr. Haygood a specific date? The 29th, can you get
- 4 this within a week? Is a week good enough, everybody,
- 5 for him to make sure that we have everything, and then
- 6 we'll all have at least two weeks to look over it and
- 7 to meet with them before that 13th meeting?
- 8 MR. HAYGOOD: I'm not -- the only -- we
- 9 certainly can get the job description information for
- 10 you. The only thing I'm not sure of is we would have
- 11 quotes from the three firms, at least three firms for
- 12 you all to consider for the national search.
- 13 COMMISSIONER MILLER-ANDERSON: Okay, can you
- 14 at least attempt that --
- MR. HAYGOOD: Yes.
- 16 COMMISSIONER MILLER-ANDERSON: -- just
- 17 attempt to try to get that information? They may
- 18 already have something. You know, we just need
- 19 ballpark type things. We may not have a specific quote
- 20 because we don't know what the specific scope of
- 21 services is going to be as of right now. So if we
- 22 could at least get whatever documentation we need to
- 23 help us make a decision, at least by the 29th -- the
