#### **The Agency and the City**

Located in the heart of Fairfield County, the City of Norwalk enjoys exceptional access to the Northeast Corridor's most important cities as well as many of its finest residential communities. Situated directly on the Long Island Sound, the City's urban core neighborhoods center on the Norwalk River and Harbor. Residents and visitors enjoy 22 miles of shoreline with a unique marine ecosystem, abundant recreational opportunities, public beaches and waterfront parks. This strategic and beautiful location along with the City's inspirational urban spirit and commitment to planning and smart growth have created a momentum that is very exciting.

Like many cities across the United States, Norwalk has rediscovered the pleasures of urban living and is in the midst of significant redevelopment in its urban center. In the fall of 2019, a new 700,000 square foot shopping mall will open in South Norwalk. The Sono Collection Project, <u>https://sonocollection.com/</u>, will include Nordstrom, Bloomingdales and an Apple Store along with 80-100 smaller retail businesses. Another example of Norwalk's redevelopment success is Waypointe, a luxury mixed use development near the waterfront <u>https://www.thewaypointe.com/</u>. These and numerous other projects underway reflect the Agency's use of smart growth principles of mixed income, mixed use and transit-oriented development.

Four years ago, Norwalk was the first smaller city in the United States to receive a \$30 million Choice Neighborhoods federal grant. This grant has been used to completely renovate the City's aging public housing and upgrade the parks, infrastructure and other amenities in and around these neighborhoods. Norwalk's Housing Authority has worked closely with the community college and non- profit organizations on workforce development. The City and the Redevelopment Agency have been successful in moving neighborhoods forward while preserving their affordability and historic character.

#### **The Position in Brief**

The Executive Director is responsible for providing executive leadership for the Agency and is responsible for establishing and maintaining close working relationships with representatives of both the public and the private sectors for the achievement of the City's urban development goals and objectives.

The Executive Director leads a staff of 8 full time and one part time employee and administers an operating budget of \$1.4 million with approximately \$8 million in assets. The NRA staff also serves as the city's housing and Community Development Block Grant (CDBG) programming administrator.



## THE CHEERLEADERS FOR NORWALK'S FUTURE

#### **The Organization**

The Norwalk Redevelopment Agency <u>https://norwalkredevelopmentagency.com/</u> is a quasi-governmental organization which is governed by a five member Board of Commissioners. The Commissioners are appointed by the Mayor of Norwalk and affirmed by the Norwalk Common Council for staggered five year terms. The Commissioners annually elect the following officers: Chairman, Vice Chairman, Secretary/ Treasurer.

#### **Expectations and Projects**

The next Executive Director can expect to work on a wide variety of redevelopment projects as well as lead the agency. The following expectations are incorporated into these responsibilities:

- Preserve and enhance key community assets to strengthen urban neighborhoods and business to promote economic vibrancy.
- Preserve neighborhoods and commercial districts by rehabilitating existing structures and advance the preservation of historical and cultural buildings.
- Advance policies and programming that grow NRA assets.
- Maintain a balanced NRA budget and implement requisite financial/fiscal controls.
