

**AMENDMENT 001 TO THE AGREEMENT
WITH
CITY OF RIVIERA BEACH**

Amendment 001 entered into on _____ by and between **Palm Beach County** and the **City of Riviera Beach**

WITNESSETH:

WHEREAS, Palm Beach County entered into an Agreement (R2018-2001) with the City of Riviera Beach on October 22, 2018, to provide \$160,890 of Community Development Block Grant (CDBG) funds for street improvements along Avenue M in Riviera Beach; and

WHEREAS, the Subrecipient has requested the County to extend the Agreement and update the monthly performance requirements contained therein; and

WHEREAS, both parties desire to amend the original Agreement in accordance with the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, and various other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

A. INCORPORATION OF RECITALS

The foregoing recitals are true and correct and incorporated herein by reference. Terms not defined herein shall have the same meaning as ascribed to them in the Agreement.

B. SECTION 6: MAXIMUM COMPENSATION

Delete "December 31, 2019" and replace it with "February 28, 2020".

C. SECTION 7: TIME OF PERFORMANCE

Delete "January 31, 2020" and replace it with "February 28, 2020".

D. EXHIBIT A – WORK PROGRAM NARRATIVE: SECTION I.G – MONTHLY PERFORMANCE REQUIREMENTS

Delete the Monthly Performance Requirements and dates and replace them with the following:

Advertise, Accept Bids and Award Contract by:	March 2019
Start Construction by:	June 2019
34% of Funds Expended by:	July 15, 2019
Complete Construction by:	December 2019
Submit Final Reimbursement by:	January 2020
100% of Funds Expended by:	February 2020

NOTE: 100% of the CDBG funds awarded must be expended by February, 2020, and all necessary reimbursement documentation to meet this expenditure requirement must be submitted to HES, no later than January, 2020.

Except as modified by this Amendment 001, the Agreement remains unmodified and in full force and effect in accordance with the terms thereof. This Amendment 001 is expressly contingent upon the approval of the County and shall become effective only when signed by all parties.
