**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING THE FIRST AMENDMENT TO THE MUTUAL USE INTERLOCAL AGREEMENT OF DAN CALLOWAY PARK BETWEEN THE PALM BEACH COUNTY SCHOOL DISTRICT AND THE CITY OF RIVIERA BEACH AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE SAME; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Riviera Beach and the Palm Beach County School District (School District) have enjoyed joint use of facilities for many years; and

**WHEREAS**, the School District is reconstructing Washington Elementary School and relocating students to Lincoln Elementary School; and

**WHEREAS**, the School District wishes to amend the existing Interlocal Agreement's termination date.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:**

**SECTION 1.** The City Council approves the First Amendment to the Interlocal Agreement for Dan Calloway Park terminating August 31, 2021.

**SECTION 2.** That the Mayor and City Clerk are authorized to execute the amended Interlocal Agreement.

**SECTION 3.** This Resolution shall take effect upon its passage and approval by the City Council.
