FIRST AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN THE SCHOOL BOARD OF PALM BEACH COUNTY AND THE CITY OF RIVIERA BEACH FOR USE OF RECREATIONAL FACILITIES AT DAN CALLOWAY-TATE RECREATION CENTER BY LINCOLN ELEMENTARY SCHOOL

THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT (the "Amendment") is made and entered into as of _______, 2020 by and between **THE CITY OF RIVIERA BEACH**, (hereinafter referred to as "**CITY**") and the **SCHOOL BOARD OF PALM BEACH COUNTY, FLORIDA**, a corporate body politic, (hereinafter referred to as "**BOARD**").

WHEREAS, the BOARD and CITY entered into an Interlocal Agreement dated June 19, 2019 (hereinafter referred to as "AGREEMENT"), wherein the CITY agreed to allow the BOARD to utilize the facilities at Dan Calloway-Tate Recreation Center adjacent to Lincoln Elementary School between August 2019 and December 2020; and

WHEREAS, the BOARD and CITY desire to amend the AGREEMENT; and

NOW, THEREFORE, the parties hereby agree as follows:

 The foregoing recitals are true and correct and incorporated herein by reference. Terms not defined herein shall have the same meaning as ascribed to them in the AGREEMENT. 2. Section 2.A of the AGREEMENT is hereby deleted in its entirety and replaced with the following:

This AGREEMENT shall begin on August 1, 2019 and shall end on August 31, 2021, however, both parties reserve the right to terminate the AGREEMENT without cause upon thirty (30) days written notice to the other party.

 Except as set forth herein, the AGREEMENT remains unmodified and in full force and effect, and the BOARD and CITY hereby ratify, confirm and adopt the AGREEMENT as amended hereby.
