- SUBJECT: Update on the Signage Improvement Grant Program from Treasure Coast Regional Planning Council

#### BACKGROUND AND PROGRAM UPDATE

The Agency approved the development of the Signage Improvement Grant Program in 2019. See the attached Resolution No. 2019-14. This grant program, along with a general program description, funding was approved for \$220,000.00 in the FY 2020-2021 Budget.

Staff is desirous of implementing the Signage Improvement Grant Program (SIGP) in the current quarter. The signage program will provide commercial properties with financial assistance (grants) to improve the existing signage along our major right-of-way corridors in the CRA. Attractive signage not only improves the appearance of our neighborhood but benefits the visibility of businesses in our community. The program is for commercial properties located in the CRA District located on Blue Heron Boulevard and Broadway Avenue. Residentially zoned properties are excluded. All proposed exterior improvements must meet the CRA's guidelines and be approved by the CRA Board.

#### **CURRENT STATUS**

The Agency and Treasure Coast Regional Planning Council (TCRPC) have crafted a selection and ranking criteria which will be used to evaluate all the proposed candidates, and list them in order of importance.

## **COMPLETED TASKS**

The following tasks from initiation of the signage program have been completed:

- Surveyed blue Heron & Broadway Corridors to assess conditions
- Developed typical cost estimates with sign company for potential signage improvement candidates
- Initiated "gateway" business signage concept with sign company
- Program interest letters were sent to the identified properties
- Developed preliminary Signage Grant Program Selection Criteria
- Signage program survey was posted to solicit resident and stakeholder feedback
- Mailer was drafted and will be sent out to all businesses in the RBCRA District
- Interviews were scheduled for interested business/property owners
- Closing of survey data collection October 1, 2020

## **IMPLEMENTATION STRATEGY**

The CRA, in collaboration with TCRPC, will complete the following:

- Production of illustrative graphics
- Study of "Wayfinding Destinations" determination of best locations for Wayfinding Signage
- Finalize Program selection criteria
- Continued outreach to property owners
- Review and score prospective grant applications from business owners
- Finalize a draft signage option for each of the prospective grantees

• Complete drafts of the proposed signage design will be brought to the Board for final review and approval
