Background:

Solicitation Requested By: Public Works Department

Consistent with the City of Riviera Beach Code of Ordinance (MUNICODE Section 16.5), a Request for Qualifications (RFQ) was advertised in the "Legal Notices" section of the Palm Beach Post on September 6, 2020 and on the City's website on September 7, 2020, to solicit a firm for Engineering Consulting and Surveying Services for the City of Riviera Beach.

To provide additional exposure and to ensure maximum competition for the project, it was also advertised on DemandStar on **September 8, 2020**. The City received thirteen (13) proposals for Engineering and three (3) proposals for Surveying. There are three firms from Riviera Beach; ten firms from Palm Beach County; one firm from Broward and two firms from Miami/Dade County.

Firms were evaluated and ranked based on the criteria established in the City's RFQ. Scores for the written proposals (**Phase** 1) were tallied, and based upon a measure of average score, the firms ranked as follows:

The evaluation process has validated that the proposals submitted by AE Engineering; Erdman Anthony; Engenuity Group; Chen Moore and Associates; Brown Phillips; and KCI Technologies satisfies the requirements established in the RFQ and the firms are qualified to be awarded a contract for the services identified in RFQ #1009-20-4.

These firms specializes in providing Engineering and Surveying Services and have substantial experience in providing the types of services required by the City.

Accordingly, and consistent with the provisions of the solicitation, it is the consensus of the evaluation committee that the top four (4) ranked firms and the top three (3) ranked firms be recommended to provide Engineering and Surveying Services for the City of Riviera Beach.
