NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF RIVIERA BEACH UTILITY SPECIAL DISTRICT, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

<u>SECTION 1.</u> That the Board of Directors of the City of Riviera Beach Utility Special District accepts the proposed scope of work to support Design Build projects underway, evaluate critical processes, and develop a framework for project management.

SECTION 2.. That the Utility Special District Finance Director is authorized to make payments from Project Number 21017 for work authorization issued by the Executive Director of Utilities in an amount not to exceed \$196,540.00.
