**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE SALE AND TRANSFER OF RETIRED K-9 POLICE DOG "MILLOW" IN THE AMOUNT OF \$1.00 AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE BILL OF SALE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, K-9 Millow, a nearly seven (7) year old German Shepherd dog, served the Riviera Beach Police Department with distinction; and

**WHEREAS**, K-9 Millow shall be retired from service as a member of the Riviera Beach Police Department; and

**WHEREAS**, K-9 Millow shall be removed from the inventory of the Police Department by sale and transfer of ownership.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA, that:**

**SECTION 1.** The City Council authorizes the sale and transfer of City property, specifically, one German Shepherd dog known as "Millow".

**SECTION 2.** The City Council authorizes the City Manager and City Clerk to execute the Bill of Sale between Former Police Officer William Loudon and the City of Riviera Beach.

**SECTION 3.** This Resolution shall take effect immediately upon its passage and approval by the City Council.
