WHEREAS, the grant program will assist in the purchase of bulletproof vests for law enforcement officers during the fiscal year, with the budgeted award dates of August 30, 2020 – August 31, 2022; and

WHEREAS, the City has been awarded grant funds in the amount of \$15,844.73, with a required cash match of \$15,844.73, totaling vest purchases of \$31,689.46.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA, that:

SECTION 1: The City Council is authorized to accept grant funds in the amount of \$15,844.73 from the Bulletproof Vest Partnership Grant Program.
