A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ACCEPTING THE RECOMMENDATION OF STAFF AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THREE YEAR CONTINUING SERVICE AGREEMENTS WITH THE FIRMS OF ALL-SITE CONSTRUCTION INC., BUILT SOLID CONSTRUCTION LLC., E&F FLORIDA ENTERPRISES INC., EMERALD CONSTRUCTION CORP., HELINA CONSTRUCTION LLC., I.Q. CONSTRUCTIONS INC., J AND J CONSTRUCTION CORP., NEWBOLD CONSTRUCTION INC., RANDOLPH CONSTRUCTION GROUP. SHAMTEC INC., AND SHAWMUT DESIGN CONSTRUCTION TO PROVIDE RENOVATION AND CONSTRUCTION SERVICES FOR VARIOUS CITY-WIDE PROJECTS; PROVIDING FOR TWO (2) ADDITIONAL TWELVE (12) MONTH RENEWAL OPTIONS BASED UPON THE MUTUAL CONSENT OF THE PARTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City often requires the services of construction firms to provide renovation and construction services for a multitude of projects within the City; and

WHEREAS, in accordance with the provisions of the City's Procurement Ordinance No. (4010), staff solicited Request for Qualifications for Various Architectural Consulting Services and the selection committee qualified eleven (11) firms as a pool of vendors for renovation services; and

WHEREAS, the eleven (11) firms were selected to provide the services identified in the City's Request for Qualifications;

NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1: The City Council hereby approves award of RTQ 1005-20-4 and contracts between the City of Riviera Beach and All-Site Construction Inc., Built Solid Construction LLC., E&F Florida Enterprises Inc., Emerald Construction Corp., Helina Construction LLC., I.Q. Constructions Inc., J and J Construction Corp., Newbold Construction Inc., Randolph Construction Group, Shamtec Inc., and Shawmut Design and Construction.

SECTION 2: That the City Council authorizes the Mayor and City Clerk to execute the contracts with All-Site Construction Inc., Built Solid Construction LLC., E&F Florida Enterprises Inc., Emerald Construction Corp., Helina Construction LLC., I.Q. Constructions Inc., J and J Construction Corp., Newbold Construction Inc., Randolph Construction Group, Shamtec Inc., and Shawmut Design and Construction to provide Renovation and Construction Services for the City of Riviera Beach.
