

## **RESOLUTION NUMBER 110-20**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ACCEPTING THE RECOMMENDATION OF STAFF AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A THREE YEAR CONTINUING SERVICES CONTRACT TO PROVIDE PROFESSIONAL ENGINEERING AND SURVEY SERVICES WITH AE ENGINEERING OF RIVIERA BEACH, ERDMAN ANTHONY OF WEST PALM BEACH, CHEN MOORE ASSOCIATES OF WEST PALM BEACH, KCI TECHNOLOGIES OF FT. LAUDERDALE, ENGENUITY GROUP OF WEST PALM BEACH, AND BROWN AND PHILLIPS OF WEST PALM BEACH FLORIDA; PROVIDING FOR TWO (2) ADDITIONAL TWELVE (12) MONTH RENEWAL OPTIONS BASED UPON THE MUTUAL CONSENT OF THE PARTIES; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City often requires the services of professional engineering survey firms to provide survey, engineering design, and consulting services for a multitude of projects within the City; and

**WHEREAS**, in accordance with the provisions of the City's Procurement Ordinance No. 4010, staff solicited Request for Qualifications for various Survey and Engineering Consulting Services; and

**WHEREAS**, the selection committee ranked the sixteen (16) firms that submitted in accordance with the State of Florida's "Consultants' Competitive Negotiation Act" (FS 287.055) namely; and

**WHEREAS**, the top four firms in both Engineering and Surveying services were selected to provide the services identified in the City's Request for Qualifications.

**NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:**

**SECTION 1:** The City Council hereby approves the contract between the City of Riviera Beach and Chen Moore Associates, Erdman Anthony, AE Engineering, KCI Technologies, Engenuity Group, and Brown and Phillips.

**SECTION 2:** That the City Council authorizes the Mayor and City Clerk to execute the contracts with Chen Moore Associates, Erdman Anthony, AE Engineering, KCI Technologies, Engenuity Group, and Brown and Phillips to provide Survey and Engineering Consulting Services for the City of Riviera Beach.

**SECTION 3:** This Resolution shall take effect upon its passage and approval by the City Council.
