

RESOLUTION NUMBER 112-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ACCEPTING THE RECOMMENDATION OF STAFF AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A THREE YEAR CONTINUING SERVICE AGREEMENTS WITH THE TOP FOUR RANKED FIRMS OF SONG & ASSOCIATES INC., REG ARCHITECTS, INC., ALPHONSO HERNANDEZ ARCHITECT, AND WEST ARCHITECTURE AND DESIGN, LLC. TO PROVIDE PROFESSIONAL ARCHITECTURAL SERVICES FOR VARIOUS CITY-WIDE PROJECTS; PROVIDING FOR TWO (2) ADDITIONAL TWELVE (12) MONTH RENEWAL OPTIONS BASED UPON THE MUTUAL CONSENT OF THE PARTIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City often requires the services of professional architectural firms to provide architectural design and consulting services for a multitude of projects within the City; and

WHEREAS, in accordance with the provisions of the City's Procurement Ordinance No. 4010, staff solicited Request for Qualifications for Various Architectural Consulting Services; and

WHEREAS, the selection committee ranked the six (6) firms that submitted in accordance with the State of Florida's "Consultants' Competitive Negotiation Act" (FS 287.055) namely; and

WHEREAS, the top four firms were selected to provide the services identified in the City's Request for Qualifications.

NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

SECTION 1: The City Council hereby approves award of RFP 1003-20-4 and contract between the City of Riviera Beach and Song & Associates, Inc., REG Architects, Inc., Alphonso Hernandez Architect, and West Architecture & Design.

SECTION 2: That the City Council authorizes the Mayor and City Clerk to execute the contracts with Song & Associates, Inc., REG Architects, Inc., Alphonso Hernandez Architect, and West Architecture & Design to provide Architectural Consulting Services for the City of Riviera Beach.

SECTION 3: This Resolution shall take effect upon its passage and approval by the City Council.
