- 4. In order to avoid the cost and uncertainties of litigating the matter, the parties have agreed that Michael H. Stauder Sr., Esq. is entitled to a reasonable attorney's fee and taxable costs which will be paid at the expense of the Employer/Servicing Agent, under Florida Statute Section 440.34 for the procurement and time expended for those benefits outlined in the Verified Petition for Attorney Fees and Costs filed on or about September 15, 2020 and per the Amended Final Order entered on August 14, 2020.
- The Employer/Carrier has agreed to pay and the Claimant's attorney, Michael H. It is the understanding and agreement of the parties that with payment of the aforesaid attorney fees and taxable costs, any and all attorney fee and taxable cost issues through the date of the Order approving this stipulation are resolved and all Petitions for Benefits filed prior to the filing of the Amended Verified Motion for Attorney Fees and Costs referenced herein are dismissed.
