Consistent with the City of Riviera Beach Code of Ordinance (MUNICODE Section 16.5), a Request for Proposal (RFP) was advertised in the "Legal Notices" section of the Palm Beach Post on October 11, 2020, to solicit a firm for Impact Fee Study Services for the City of Riviera Beach.

To provide additional exposure and to ensure maximum competition for the project, it was also advertised on the City's internet web page on **October 7**, **2020**. The solicitation was broadcasted and three (3) proposals were received from respondents within Florida.

Firms were evaluated and ranked based on the criteria established in the City's RFP. Scores for the written proposal (**Phase** 1) were tallied, and based upon a measure of average score, the firms ranked as follows:

Tindale Oliver	2	68.60
Raftelis	3	59.00

The evaluation process has validated that the proposal submitted by MGT Consulting satisfies the requirements established in the RFP and that the firm is qualified to be awarded the contract for the services identified in RFP #1010-21-1.

MGT Consulting is a national firm that specializes in providing Impact Fee Study services and have substantial experience in providing the types of services required by the City.

Accordingly, and consistent with the provisions of the solicitation, it is the consensus of the evaluation committee that the number one (1) ranked firm, MGT Consulting be recommended to provide Impact Fee Study services for the City of Riviera Beach.
