**SECTION 1.** The herby approves the contract with Chris Wayne and Associates for the landscaping and irrigation services for the 2600 Broadway project for an amount not to exceed \$87, 728.00 plus a 10% contingency substantially in the form of Exhibit "A" attached hereto.

**SECTION 2.**That Chairman and Executive Director are authorized to execute the contract with Chris Wayne and Associates, Inc., in substantially the form of Exhibit "A" attached hereto.
