## **RESOLUTION NO. 2021-**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY (THE AGENCY) APPROVING THE EXERCISE OF AN ONE-YEAR OPTION TO EXTEND A CONTRACT BETWEEN THE AGENCY AND BRIGHTVIEW LANDSCAPE SERVICES, INC., TO MAY 30, 2022, TO MAINTAIN THE LANDSCAPING AND IRRIGATION OF THE MARINA VILLAGE UPLANDS, PROMENADE, BICENTENNIAL PARK, AND OTHER DESIGNATED AREAS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Agency is responsible for carrying out the community redevelopment activities and the projects in the community redevelopment area of the City of Riviera Beach, Florida; and

WHEREAS, the Agency is responsible for the maintenance of the landscape and irrigation of the Marina Uplands, Promenade, Bicentennial Park, Avenue "C" Corridor from 11th Street to 15th Street, 13th Street Corridor from Avenue "C" to Broadway, and the parcel of land formerly known as Spanish Courts; and

WHERAS, the Agency and Contractor entered into a Professional Services Agreement dated April 24, 2019 for landscape maintenance services for the Marina Uplands, Promenade, Bicentennial Park, Avenue "C" Corridor from 11th Street to 15th Street, 13th Street Corridor from Avenue "C" to Broadway, and the parcel of land formerly known as Spanish Courts (the "Contract"); and

WHEREAS, the Contract provided for a 24-month term with an option for oneyear extension; and

WHEREAS, Contractor and Agency wish to modify the Contract to exercise the option and extend the term of the Contract to May 30, 2022 upon the same terms and conditions as the Contract.
