A CORPORATION AUTHORIZED TO DO BUSINESS IN THE STATE OF FLORIDA; COOPERATIVE CONTRACT NUMBER 062320 WITH SOURCEWELL FOR RENTAL OF EMERGENCY EQUIPMENT; AND AUTHORIZING THE UTILITY SPECIAL DISTRICT FINANCE DIRECTOR TO MAKE PAYMENT FROM ACCOUNT NUMBER 41131103-543000 IN AN AMOUNT NOT TO EXCEED \$150,000.00; FROM ACCOUNT NUMBER 41131104-543000 IN AN AMOUNT NOT TO EXCEED \$50,000.00; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Utility Special District (District) wishes to utilize Sourcewell's cooperative purchasing contract with United Rentals (North America), Inc., to provide emergency equipment.

NOW, THEREFORE, BE IT RESOLVED BY THE UTILITY SPECIAL DISTRICT BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AS FOLLOWS:

SECTION 1. That the District Board approves utilizing the cooperative contract with United Rentals (North America), Inc. in the amount not to exceed \$200,000.00 annually to provide equipment on an as needed basis.

SECTION 3. That the Board authorize the Utility Special District Finance Director to make payment from Account Number 41131103-543000 in an amount not to exceed \$150,000.00 and make payment from Account Number 41131104-543000 in an amount not to exceed \$50,000.00;
