A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ACCEPTING THE RECOMMENDATION OF STAFF AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE CONTINUING SERVICES CONTRACTS TO **PROFESSIONAL PROVIDE** MARINE/COASTAL ENGINEERING CONSULTING SERVICES WITH EACH OF THE **TOP** THREE **RANKED** FIRMS, DIVERSIFIED, INC. OF DELRAY BEACH, FLORIDA CUMMINS CEDERBERG, INC. OF JUPITER, FLORIDA, AND EDGEWATER RESOURCES, LLC OF POMPANO BEACH, FLORIDA COMMENCING JUNE 3, 2021 AND ENDING JUNE 2, 2024 WITH RENEWAL OPTIONS FOR TWO (2) ADDITIONAL TWELVE (12) MONTH PERIODS; AUTHORIZING THE FINANCE DIRECTOR TO MAKE PAYMENTS FROM THE APPROPRIATE OPERATING ACCOUNTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, in accordance with the provisions of the City's Procurement Ordinance, staff solicited Request for Qualifications (RFQ No. 1023-21-2 for Professional Marine/Coastal Engineering Consulting Services for Improvements to the City of Riviera Beach Marina; and

WHEREAS, the selection committee short-listed three (3) firms in accordance with the State of Florida's "Consultants' Competitive Negotiation Act" (Florida Statute 287.066) namely Sea Diversified, Inc., Cummins Cederberg, Inc., and Edgewater Resources, LLC; and

**WHEREAS**, Sea Diversified, Inc. of Delray Beach, Florida was selected as the number one ranked firm, and Cummins Cederberg, Inc. of Jupiter, Florida was selected as the number two ranked firm, and Edgewater Resources, Inc. of Pompano Beach, Florida was selected as the number three ranked firm to provide the services identified in the City's Request for Qualifications.

**NOW, THEREFORE**, be it resolved by the City Council of the City of Riviera Beach, Palm Beach County, Florida, Florida, as follows:

**SECTION 1.** That the Council approves continuing services contracts between the City of Riviera Beach and Sea Diversified, Inc. of Delray Beach, Florida, Cummins Cederberg, Inc. of Jupiter, Florida, and Edgewater Resources, Inc. of Pompano Beach, Florida.

SECTION 2. That the City Council authorizes the Mayor and City Clerk to execute the contracts with Sea Diversified, Inc. of Delray Beach, Florida, Cummins Cederberg, Inc. of Jupiter Florida, and Edgewater Resources, Inc. of Pompano Beach, Florida.
