A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A CHANGE ORDER WITH BROTHERS CONSTRUCTION OF STUART, FLORIDA AND ERDMAN ANTHONY OF WEST PALM BEACH, FLORIDA FOR COSTS ASSOCIATED WITH REDESIGN OF THE GRAND BAHAMA BRIDGE AND ASSOCIATED CONSTRUCTION OVERSIGHT SERVICES IN THE AMOUNT OF \$1,070,503.39 AND \$202,000 RESPECTIVELY; AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO TEN PERCENT (10%); AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENT FOR SAME FROM PROJECT NUMBER 18097 AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on September 24, 2020 the City Council approved Resolution 86-20 for Bid 996-20-1 the reconstruction of the Palm Beach Isles Bridges and approved RFP 1009-20-4 for Engineering and Survey continuing services; and

WHEREAS, on November 18, 2020 the City Council approved Resolution 111-20 for redesign of the Grand Bahama Bridge and Construction Administration for Erdman Anthony; and

WHEREAS, Erdman Anthony having re-designed the Grand Bahama Bridge, and Brothers Construction has provided a cost of \$983,831.04 for installation of the new bridge configuration and 115 day contract extension and \$86,672.35 for prior change orders; and

WHEREAS, due to the extension of the construction period by 115 days, Erdman Anthony has requested an additional \$202,000 for construction observation and oversight.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AS FOLLOWS:

SECTION 1. That the City Council hereby approves the issuance of a change order to Brothers Construction of Stuart, Florida and Erdman Anthony of West Palm Beach, Florida for installation and construction observation of the redesigned Grand Bahama Bridge in the amount of \$1,070,503.39 and \$202,000 respectively.

SECTION 2. That the Director of Finance and Administrative Services is authorized to make payment for same from Project Number 18097.

SECTION 3. That the City Manager shall have authority to approve change orders in an amount not to exceed ten percent (10%) of the contract amount.

SECTION 4. That this Resolution shall take effect upon its passage and approval by City Council.
