

RESOLUTION NUMBER 70-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING A CHANGE ORDER TO RANDOLPH CONSTRUCTION GROUP OF RIVIERA BEACH, FLORIDA, TO RENOVATE THE RIVIERA BEACH PUBLIC LIBRARY AND EMPOWERMENT CENTER'S CAFE IN THE AMOUNT OF ONE HUNDRED FORTY FOUR THOUSAND, EIGHTY EIGHT DOLLARS AND THIRTY THREE CENTS (\$144,088.33); AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO TEN PERCENT (10%); AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENT FOR SAME FROM PROJECT NUMBER 21010; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council approved a work order to Randolph Construction Group, a Riviera Beach firm, which submitted the lowest responsive and responsible bid in the amount of \$827,786 in Resolution 08-21.

WHEREAS, the City requested modifications to the construction scope to outfit the café to meet health department standards and these changes shall cost \$144,088.33.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

SECTION 1. That the City Council hereby approves the change order proposal to Randolph Construction Group to modify the construction scope for the café within the Riviera Beach Public Library and Youth Empowerment Center in the amount of \$144,088.33.

SECTION 2. That the Director of Finance and Administrative Services is authorized to make payment for same from Project Number 21010.

SECTION 3. That the City Manager shall have authority to approve change orders in an amount not to exceed ten percent (10%) of the contract amount.

SECTION 4. That this Resolution shall take effect upon its passage and approval by City Council.
