Final Grants**

This table shows the final State Aid to Libraries grant amounts that each eligible library will receive in 2020-21. For 2020-21, the available funding for State Aid grants is \$17,304,072, which is 10.7 percent of what would be required for full funding. At this level, Operating Grants pay 1.64 cents on the dollar of expenditure by a participating library during the second preceding year. Operating Grants total \$9,847,578; Equalization Grants total \$4,581,657; and Multicounty Grants total \$2,874,837.
