A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE PAYMENT OF INVOICE # 1120-1353 to AFR ENVIRONMENTAL CORP IN THE AMOUNT OF \$45,100 FOR MOLD AND MOISTURE DAMAGE REMEDIATION IN/RECONSTRUCTION/REBUILD OF THE POLICE EVIDENCE ROOM AT CITY HALL AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City is in need of environmentally safe workspaces and a Police evidence room free and clear of contaminants and moisture that has resulted in damage to evidence and could result in further damage to City property and evidence, if not corrected; and

WHEREAS, the City hired AFR Environmental Corp. to perform services to remediate mold, repair and rebuild building materials damaged by moisture, and to water proof the area to mitigate potential future water intrusion.

WHEREAS, the AFR Environmental Corp performed said services on and between October 29, 2020 – December 4, 2020.

WHEREAS, City staff recommends the invoice be paid to AFR Environmental Corp. for services performed October 29, 2020 – December 4, 2020.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

SECTION 1. That staff is hereby authorized make payment to AFR Environmental Corp for the effective remediation and repairs to the Police Department's Evidence Room performed October 29, 2020 – December 4, 2020.

SECTION 2. That the Director of Finance is authorized to make payment from the Risk Management account in the total amount of \$45,100.

SECTION 3. That this resolution shall take effect immediately upon its passage and approval by the City Council.
