**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY (THE “AGENCY”) APPROVING AN AGREEMENT WITH PITTMAN LAW GROUP, L.L.C. (THE FIRM), FOR A TERM OF THREE YEARS TO PROVIDE LEGAL SERVICES TO THE RBCRA AS IT’S GENERAL COUNSEL; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on June 09, 2021, after review of the proposals submitted and oral presentations, the RBCRA voted to award the contract to a legal firm; and

**WHEREAS**, Pittman Law Group, L.L.C. was selected as General Counsel to provide legal services to the RBCRA.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY THAT:**

**SECTION 1:** The recitals and findings contained in the Preamble to the Resolution are incorporated herein as if fully set forth in this section.

**SECTION 2:** The Board of Commissioners hereby authorizes the terms of the new legal team, Pittman Law Group, to provide General Counsel services to the RBCRA.

**SECTION 3:** The Chair and the Executive Director of the Agency, on behalf of the Agency, are each hereby authorized to execute and attest, respectively, the attached legal agreement.

**SECTION 4:** This resolution shall be effective immediately upon its adoption.
