A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND EXECUTION OF A GRANT AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF AGRICULTURE FOR \$50,000 TO ASSIST WITH EXPANDING COMMUNITY GARDENS AND THE URBAN FARM; AUTHORIZING THE CITY MANAGER TO EXECUTE THE APPLICATION; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE SAID AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Agriculture has funding for expansion of community gardens and urban farms; and

WHEREAS, the City of Riviera Beach has the opportunity to upgrade community gardens and the urban farm programs and services through education, plant and produce availability and sustainable urban agriculture practices; and

WHEREAS, staff has identified upgrades that can be funded through the Florida Department of Agriculture grant for \$50,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:

SECTION 1. The City Manager is hereby authorized to execute the grant submittal for the Florida Department of Agriculture.

SECTION 2. That the Mayor and City Clerk are hereby authorized to execute the agreement for same.

SECTION 3. This Resolution shall take effect upon its passage and approval by the City Council.
