Background:

At the August 4, 2021 City Council Meeting, a presentation was made to the City Council on "Reimagine Riviera Beach". The City Council directed staff to bring back this issue on September 15, 2021 for discussion and deliberation of the New City Hall location.

Since June 2019, the City Council has held numerous meetings and many other public discussions regarding "REIMAGINE Riviera Beach -2030". Some of the more recent meetings and public engagement activities include, but are not limited to:

- A 4-part workshop, including broadcasting, on June 8.15. 22 and 29, 2021.
- Congress Corridor Community Meeting, including broadcast, on August 5, 2021.
- Park Manor Association Meeting on August 19, 2021.
- Video Presentation and Online Poll, to be released the week of September 7, 2021.
- Employee Reimagine Session on October 14^{th,} 2021.
