VOCA-2021-CITY OF RIVIERA BEACH POL-00676 FOR THE VICTIM ADVOCATE PROGRAM AWARDING FUNDS IN THE AMOUNT NOT TO EXCEED \$253,816.00, FROM OCTOBER 1, 2021, THROUGH SEPTEMBER 30, 2022, TO CONTINUE WITH CRISIS RESPONSE SERVICES FOCUSING IN AREAS OF HOMICIDE, DOMESTIC VIOLENCE, CHILD DEATHS, AND ELDERLY VICTIMIZATION; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A CERTIFICATE OF ACCEPTANCE OF THE GRANT AWARD; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO SET UP THE BUDGET IN FUND 226; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The Office of the Attorney General has established a Victims of Crime Act (VOCA) Grant Program; and

WHEREAS, City of Riviera Beach, in Grant No. VOCA-2021-City of Riviera Beach Pol-00676 has been awarded funds in the amount not to exceed \$253,816.00 that waives the usually required a twenty percent match; and

WHEREAS, This Grant Award includes the positions of two full-time Victim Advocates and two part-time Victim Advocate Assistants; and

WHEREAS, VOCA Grant No. VOCA-2021-City of Riviera Beach Pol-00676 is a Reimbursement Grant, which includes funding for personnel (including salary, benefits, leave, etc.), Operating Expenses, and Training, which are reimbursed monthly; and

WHEREAS, These funds will be used for continuing the Department's crisis response services, crisis intervention, and assisting investigators.
