## **Republican governor battles the Democratic president over vaccines**

TALLAHASSEE – Gov. Ron DeSantis said Thursday that Florida is suing to block the newly released Biden administration rule that larger employers assure their workers are vaccinated or undergoing frequent testing for COVID-19.

The Republican governor called the White House approach unconstitutional and a certain drag on the economy.

"Individuals should make informed choices about their own health care. They shouldn't be coerced into getting a jab," DeSantis said. "In this situation, you're going to have people that are going have to make that decision, do you get fired from your job or do you do this that's something you may not want to do."

Florida is asking the U.S. Ifth Circuit Court of Appeals to halt the new rule, issued by the Occupational Safety and Health Administration. The rule requires companies with 100 or more employees to ensure by Jan. 4 that workers are fully vaccinated or test negative for COVID-19 at least once a week.

A number of Republican-led states are expected to file similar lawsuits challenging the OSHA rule, which had been promised by Biden but which took weeks to fully develop before being rolled out Thursday.

DeSantis has already called Florida lawmakers into a special session beginning Nov. 15 to block the vaccine mandate on businesses, along with enacting steps to strengthen the state's Parents Bill of Rights law that he's used to combat mask mandates in schools.

DeSantis said the lawsuit doesn't disrupt plans for the special session, although he held out hope that judges could already block enforcement of the rule by then. The governor cited as a problem with the rule its lack of making any accommodation for workers who already contracted COVID-19 and built up some level of immunity.

DeSantis has relied on advisors, including controversial new Florida Surgeon General Joseph Ladapo, who have advocated that herd immunity is a way of combatting the virus, while downplaying the importance of vaccines and mitigation efforts.

About 60,000 Floridians have died from COVID-19, while 3.6 million have been sickened. Just under 60% of the population has been fully vaccinated, ranking the state 21st in the nation.

"I just think people are so sick of constantly being bossed around, restricted, mandated all these different things. We've had enough of it," DeSantis said of the new OSHA rule. "We want people to be able to make their own decisions." The lawsuit is the third that Florida under DeSantis has filed in recent weeks against the Biden administration. DeSantis, who faces a re-election campaign next year but is already eyed as a possible Republican presidential contender in 2024, has sued over federal immigration policy and vaccine requirements for federal contractors.

Critics see the governor intent on enacting state policies that amplify his standing with the conservative voting base stirred by former President Donald Trump.

For months, DeSantis has been emailing campaign fund-raising pitches to supporters almost immediately after putting in play proposals involving immigration, social media sites and his support for law enforcement.

One of three Democrats challenging him for governor next year, Agriculture Commissioner Nikki Fried, condemned DeSantis' effort to block measures aimed at reducing the threat of COVID-19.

"The governor himself is now trying to enact his own mandates to block businesses, local governments, and school boards from protecting their own constituents," Fried said. "Once again, Gov. DeSantis is putting his personal ambitions ahead of the wellbeing of Floridians."

DeSantis said the state is also preparing to challenge other Biden emergency regulations unveiled Thursday for health care workers, including those at nursing homes caring for elderly and sick residents at high risk for COVID-19.

The new regulations require workers at health care facilities receiving either Medicare or Medicaid funding to be vaccinated by Jan. 4, with no option of being tested instead.

DeSantis said the White House was making an "attempt to shoehorn policy through...bureaucracy," and avoid seeking congressional approval for such action. The governor predicted Congress would not approve the requirements.

At a time when the economy is struggling with supply chain problems, an uptick in inflation, and job creation levels that are less than expected, DeSantis warned that the new vaccine mandates would cause more disruption to businesses and the workforce.

"The practical result of this is it's going to exacerbate a lot of what we're seeing with the economy," he said, adding, "this is going to cause more economic pain."
