WHEREAS, in accordance with the provisions of the City of Riviera Beach Procurement Code Chapter 16.5 (Municode), request for Bids were publicity solicited through BID 507-15 Citywide Auto Detailing to provide washing and detailing of City owned vehicles for various City Departments. and

WHEREAS, City departments have budgeted funds for the maintenance and repair of City vehicles; and

WHEREAS, three proposals were submitted and the evaluation process has validated that the BID submitted by Dirt & Restoration Custom Auto Detailing satisfies the requirements established in the solicitation; and

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

SECTION 1: The City Council hereby approves staff's recommendation and the negotiated terms for Citywide Auto Detailing services and awards a two (2) year service contract to Dirt & Restoration Custom Auto Detailing of Riviera Beach, Florida, and authorizes the Mayor and City Clerk to execute same.

SECTION 2: That Mayor and City Clerk is hereby authorized to execute the contract.

SECTION 3: That the City Manager is hereby authorized to execute renewals as detailed in the contract.

SECTION 4: That the Director of Finance and Administrative Services is authorize to make payments from the appropriate operating accounts.

SECTION 5: This Resolution shall take effect immediately upon its passage and approval.
