**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AND AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A CONTRACT WITH ADVANCED DATA PROCESSING, INC., (ADPI) DBA INTERMEDIX FOR EMERGENCY MEDICAL TRANSPORTATION BILLING SERVICES, AUTHORIZING THE FINANCE DIRECTOR TO MAKE PAYMENT FROM BUDGET ITEM 001-0921-526-0-3105; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Riviera Beach Fire Rescue provides emergency medical service transport to the citizens and visitors of the City of Riviera Beach, and

**WHEREAS**, Advanced Data Processing, Inc. dba Intermedix (ADPI) currently provides month-to-month service to the City of Riviera Beach at a billing rate of 6.8% in monies collected by the Contractor excluding Medicaid accounts and a Medicaid billing rate of \$10.50 per account, and

**WHEREAS**, The City of Palm Beach Gardens has a contract that allows to be piggybacked at a billing rate of 4.75% and a flat rate of \$7.00 per Medicaid Claim, and

**WHEREAS**, Advanced Data Processing, Inc. dba Intermedix (ADPI), and the City of Palm Beach Gardens have provided written authorization to piggyback the City of Palm Beach Gardens contract RFP2012-004FR, and

**WHEREAS**, The contract will provide better rates to the City for services and the existing contractor handling the month-to-month billing for the City of Riviera Beach is the same as the one proposed in the piggyback with the City of Palm Beach Gardens and ADPI, which would promote a smooth transition for Fire and Finance with the new billing rates.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:**

**SECTION 1.** The City authorize the piggyback of the City of Palm Beach Gardens and ADPI with current terms and conditions.

**SECTION 2.** That the Mayor and City Clerk are authorized to execute the contract.

**Section 3.** This Resolution shall take effect upon its passage and approval by the City Council.
