Highlights

The following was provided by FFA Program Director Capt. Bob Cawood:

5/25/16

I met the Atkins groups this afternoon for fishing lessons, and on the agenda for the day was a review of the fishing laws and a fishing game designed to teach the laws. The students had a blast casting and catching the fish, and toward the end of the session, they began to better understand how to read the fishing laws, and why we have them.

5/26/16

I met the students from the Boys and Girls Club again this afternoon, and we continued on our discussion regarding water and fishing safety. We also played the Great Lifejacket Relay Race once we were done, so the students could practice putting on a lifejacket in a rush under pressure.

5/27/16

I met the Seagull students again this morning, and we reviewed water and kayak safety, because they will be kayaking with us over the summer. We also practiced using and putting on snorkeling equipment, and discussed how to best and correctly use the equipment.

5/28/16

This morning was Marina Day and Kids Fun Day at the marina. Throughout the day, parents and kids had fun playing Backyard Bass and kayaking. We also had a full boatload of people show up to take a ride on the Thea Marie. Capt. Rich and Capt. Chip took the group for a tour around Peanut Island, and then headed out to the ocean, where the group was able to see a variety of marine life. A number of families expressed an interest in summer camp, and we were able to sign up some local kids for our remaining spots, which are now full.

5/31/16

We met the graduating students from Seagull Academy this morning for their annual graduation field trip. The boat was divided into two groups: students who were bottom fishing and those who were drift fishing. The drift fishing was slow, but some of those students did manage to catch a few sandtile fish, small groupers and a mutton snapper. But the bottom fishing was hot, and those students caught fish after fish, including yellowtail snapper, sandtile fish, grunts, triggerfish and blue runners.

DEEP-SEA FISHING CAMP

6/13/16

On the first day of Deep Sea Camp, we were happy to see some new faces as well as some returning campers from previous summers. We went over the different aspects of the boat, boating safety and our goals for camp. We explained why ethical angling is important and why releasing the smaller fish keeps the fish population healthy. We showed the kids how to tie their own rigs, including lines, hooks, swivels and weights. We showed the kids safe knife skills and how to cut squid and correctly hook sardines for bait. We also showed them how to safely unhook a fish using a de-hooker. The kids exhibited a wide range of fishing expertise, and the more experienced helped the beginners, which was great to see. As we headed to sea, we spotted green sea turtles and tarpon fish. We had a great time drift fishing offshore and caught many triggerfish, remoras, grunts, snapper and more.

6/14/16

Before we left the dock for our day of fishing, we reviewed what we had learned the first day and outlined our goals for day two. We had fun drift fishing again at different depths, catching many of the same fish and even an African pompano. A shark swam by at one point, and the kids went wild trying to catch it. An enormous barracuda also attacked a grouper one of the kids was trying to reel in, right at the surface of the water. We tried to catch it, but it got away, although you wouldn't know it by how excited the kids were about the experience. When we got back to the marina, we let the kids fish for big jacks and smaller barracuda as Capt. Rich and

Capt. Chip cleaned the fish, letting the kids use the scraps as bait. They loved the big fights on light tackle.

6/15/16

When the kids arrived for the third day, we had to address some poor behavior from the previous day, so we had a long discussion about being respectful and what our camp was all about. The kids responded very well to the talk. We then went trolling, with the intention of ending the day by going swimming at the reefs by the Breakers hotel. We never made it to our swimming area, though, because we caught so many fish trolling, including a ton of blackfin tuna and bonita of various sizes. We also saw sharks and turtles, and many birds. When we got back to the marina, the kids caught many big jacks and barracuda while we cleaned our fish.

6/16/16

Today wasn't quite as bountiful as Wednesday, but we again caught a number of blackfin tuna and bonita. Thunderstorms cut our time at sea short, but not before we were able to catch more triggerfish, clown fish and snapper while drift fishing. When we got back to the marina, we let the kids fish for more jack and barracuda from the dock. We are beginning to notice that the beginner anglers are getting better at rigging jigs, baiting hooks and using our de-hookers to release under-sized fish. It is also clear now that many of the kids who were strangers at the beginning of camp have become good buddies, having lots of fun joking, dancing and storytelling.

6/17/16

We set out for our final day of fishing by setting out our trolling rods on the way to the reefs by the Breakers. We caught a few blackfin tuna and bonita before making our way to the snorkeling spot. We reviewed safe swimming techniques, then let the kids jump in the water. Some of the kids had never been snorkeling before, and we were delighted to see the other more experienced kids help them without being asked to do so. Our young campers were also beginning to show excellent team behavior by working together. The kids saw big stingrays and many small reef fish, and had a great time cooling down. We then set out for more drift fishing and quickly hit schools of fish, catching triggerfish, clownfish and snapper, while having some big fights with more blackfin tuna and bonita on light tackle this time. Some of the fights lasted five minutes and some much more. The highlight of the day, though, came when we hooked a 400-pound shark. The fight lasted a long time, and we were able to get it all the way back to the boat before the line broke. Storms forced us back to the marina, where we fished our favorite spot at the docks and caught big jacks and barracuda.

FISHING TRIP SINGLE-DAY SESSIONS

6/21/16

Riviera Beach Boys and Girls Club

We started the day on the boat by briefing students and chaperones on boating safety and rules. The conditions were too windy on the ocean, so we headed to Peanut Island, splashing the kids as we drove through the waves and they clapped and cheered for more. We anchored the boat on the east side of Peanut Island and let the kids snorkel and explore the reefs. Later, we had lunch on the boat and then fished by the FPL power plant. The kids caught many types of fish, including mutton snapper, an eel, triggerfish, a chocolate chip poggy, a tomato and many small lane snapper. We only kept a few, but the kids had a lot of fun. One of the students caught 20 fish. We then went back to the marina and let the group fish for jack. At the end of the day, we overheard some of the students say it was the best field trip they had been on.

6/22/16

Achievement Center Village Academy

We once again started the trip with a review of boating safety and rules. We left the marina and trolled on the ocean and then went drift fishing, hooking bonita and triggerfish as the kids yelled, "Fish on!" over and over. The seas got too rough, so we headed back to fish by the FPL power plant, where we caught mutton snapper, triggerfish, strawberry grouper and many small lane snapper. The fish were too small, so we could only keep one, but the kids had a lot of fun. One boy caught 11 fish.

6/23/16

South Olive Community Center

After briefing the group on safety protocols and rules, we fished on the ocean and caught triggerfish, a sand lizard, a wrasse, remora and a 10-pound kingfish. The highlight, though, was when we hooked a huge shark. We tried to reel it in for about an hour, but he got away by breaking the line. We drifted and trolled some more, then headed to the south side of the inlet and let the kids swim in the water to cool off. A few boys said they wish they could live on the boat because they were having such a great time. We then went back to the marina and showed the group how to filet a fish.

SNORKELING/KAYAKING SUMMER CAMPS

6/20/16

Two groups from Parks and Rec snorkeled and swam off the dock. The kids also fished off the dock and caught several lane snappers.

6/21/16

We took campers from the Atkins program and Acts of Kindness kayaking, and had fun leading them in a couple of races.

6/22/16

We took the Atkins group kayaking off the beach. We fished with the Acts of Kindness campers, and they caught lane snappers, puffer, blue runners and spots.

6/23/16

Our Parks and Rec students arrived for a day of snorkeling, but since we had the kayaks out, we did a little of everything, taking them kayaking, snorkeling and swimming. They found crabs, comb jellies, etc., and even helped clean the beach of trash. Our second group of the day, the Boys and Girls Club campers, kayaked and swam off the beach.

6/24/16

The first group of Boys and Girls Club kids kayaked and were excited to see fish and jellyfish. We took the second group kayaking, and the kids had fun racing with us and their counselors. They also saw even more crabs and fish, including file fish and baby triggers washing up in the seaweed.

Challenges

Sites not providing us with enough campers, and not providing us with the number of campers they agreed to bring.

The weather has been a little bit of an issue, but we have adapted by either staying in the Intracoastal or fishing from the marina docks.
