**Section 1.** That Regular City Council Meetings shall begin at 6:00 p.m. and adjourn at 10:00 p.m. unless extended by a motion of the City Council.

**Section 2.** That the Public Comments portion shall begin at approximately 7:30 p.m. or immediately thereafter unless the City's business is completed sooner, in which event Public Comments will begin sooner.

**Section 3.** That the City Council may change by majority vote any of the noted times as necessary.

**Section 4.** This resolution shall take effect on September 1, 2016.
