RE: Healthy Food Healthy Living, Inc. Grant Award and Electrical Upgrade Request

Dear Ms. Watson,

Please find attached a report of Statement of Activities for the period ending May 17, 2016 pertaining to the Riviera Beach Community Development Corporation's (RBCDC) administration of your grant award for \$7,500 from the Riviera Beach Community Redevelopment Agency (RBCRA). Through the period reported, \$7,203.44 has been expended, which represents a remaining balance of \$296.56. We are informing you that your grant will be fully funded within the next 10 days and an over-funding situation must be avoided.

There are several options that I propose below to bring funding in balance. Please advise which options you recommend or are prepared to follow.

- 1. Remit a check in the amount of \$1,782.67 payable to RBCDC. This funding will cover the budget overage for the Utilities and Repairs and Maintenance line items.
- 2. Utilities are running approximately \$820.00 per month and thus \$4,100.00 in additional funding is needed. What course of action do you propose? In order of preference, we recommend the following:
 - a. Remit an additional check for \$4,100.00 payable to RBCDC and we will increase the utilities budget to \$7,518.00.
 - b. Request additional funding from RBCRA and we will seek RBCRA Board action for funding consideration. If you pursue this option then provide a copy of your most recent tax return and listing of all bank accounts. We will require copies of your most recent bank statements from the last three (3) months.

We understand that you are requesting \$2,774 in electrical upgrades to the building. This request was discussed with RBCRA Executive Director, Tony Brown. Mr. Brown informs us that funding is not available this year but your request will be considered as part of a total budget request for Fiscal Year 2017. The RBCRA Board of Commissioners would have to take action. Please reply with your actions and proposed next steps as outlined above.
