SERVICES

Consistent with the City of Riviera Beach Code of Ordinance (MUNICODE Section 16.5), a Request for Proposal (RFP) was advertised in the "Legal Notices" section of the Palm Beach Post on June 6, 2016, to solicit qualified proposers to provide Plan Review and Inspection Services for the City of Riviera Beach.

To provide additional exposure and to ensure maximum competition for the project, it was also advertised on the City's internet web-page on **June 06, 2016**. Six (6) proposals were received.

On **July 28, 2016**, an evaluation committee consisting of Jeff Gagnon, Assistant Director of Community Development, Peter Ringle, Building Official, Brynt Johnson, Director of Public Works, DeAndrae Spradley, Principal Planner, Desai Sawyer, Accounting, Rickey Little, Purchasing Buyer, convened to review and discuss the responses to the RFP for Plan Review and Inspection Services.

Firms were evaluated in two (2) phase and ranked based on the criteria established in the City's RFP which included the following:

EVALUATION COMMITTEE RECOMMENDATION: RFP 805-16

Committee members shared their observations, and evaluated and scored the responses in accordance with their understanding of the written criteria established in the public solicitation.

Scores for the written proposal (**Phase I**) and oral presentation (**Phase 2**) were tallied, and based upon a measure of average score, the top two (2) firms ranked as follows:

C. A. P. Government, Inc.	1	101.05	
GFA International, Inc.	2	96.85	

As a result of Phase I evaluations and Phase 2 evaluations, an **overall score** was calculated based on the sum of the evaluations.

The evaluation process has validated that the proposal submitted by C. A. P. Government, Inc. satisfies the requirements established in the RFP and that the company is qualified to be awarded the contract for the services identified in RFP #805-16.

The company has substantial experience in providing the types of services required by the City. C. A. P. Government, Inc. specializes in outsourcing building department plan review and inspection services to only government agencies with a local office in West Palm Beach, Florida, that provides plan review and inspection services.

Accordingly, and consistent with the provisions of the solicitation, it is the consensus of the evaluation committee that the number one (1) ranked firm, C. A. P. Government, Inc. be recommended to provide Plan Review and Inspection Services for The City of Riviera Beach.
