**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING FIRE RESCUE TO PURCHASE ONE (1) KOHLER 50 KW NATURAL GAS POWERED EMERGENCY STANDBY GENERATOR MODLE 50REZGB UNDER QUOTE # PH-12242015-12129 REV-2 AND PURCHASING OPTION ONE (1) ADDITIONAL CONCRETE TO RAISE THE EXISTING PAD FOUNDATION AN ADDITIONAL EIGHTEEN (18) INCHES FROM THE CURRENT HEIGHT OF THE EXISTING FOUNDATION PAD. PURCHASE OPTION THREE (3) AN EXTENDED WARRANTY LASTING FIVE (5) YEARS TO COVER ALL PARTS AND LABOR. PURCHASING FROM TAW POWER SYSTEMS GROUP INC, IN THE TOTAL AMOUNT OF \$50,625.00; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE PURCHASE CONTRACT; AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO MAKE PAYMENT FROM ACCOUNT NUMBER 305-0920-522-0-6405 AND ACCOUNT NUMBER 001-920-522-0-6405, AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City Council approved the funding for Fire Rescue's Emergency Standby Generator in the 2016/17 fiscal budget; to replace the 10 year old Kato Lite existing emergency standby generator. The old emergency standby generator is costly to repair due to the salt air corrosion and the company Kato Lite is no longer in business.

**WHEREAS**, staff is requesting approval to purchase one (1) Kohler 50REZGB, 50 KW natural gas powered generator under the proposal # PH-12242015-12129 REV-2 from TAW Power Systems, Inc. of Riverview Florida. In the amount of \$ 46,875.00.

**WHEREAS**, staff is requesting approval to exercise option one (1) contained in the proposal. "Option 1 - Raise the existing concrete pad an additional 18" plus removal and replacement of cables between the generator and the automatic transfer switch to accommodate the longer length required by the increased pad height in the amount of \$2,500.00".

**WHEREAS**, staff is requesting approval to purchase option three (3) contained in the proposal. Option 3 – Five year extended warranty to cover parts and labor associated with the new Kohler emergency standby generator in the amount of \$1,250.00. Total expenditure for this purchase, service and warranty is \$50,625.00.

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF  
THE CITY OF RIVIERA BEACH, FLORIDA, THAT:**

**Section 1:** Staff is authorized to purchase one (1) Kohler 50KW Natural Gas powered generator from TAW Power Systems, Inc. of Riverview, Florida in the amount of \$46,875.00 per proposal # PH-12242015-12129 REV-2.

**Section 2:** Staff is authorized to exercise per ~~by~~ proposal # PH-12242015-12129 REV-2 Option 1 - Raise the existing concrete pad an additional 18" plus removal and replacement of cables between the generator and the automatic transfer switch to accommodate the longer length required by the increased pad height in the amount of \$2,500.00.

**Section 3:** Staff is authorized to purchase by proposal # PH-12242015-12129 REV-2 Option 3 - Five year extended warranty to cover parts and labor associated with the new Kohler emergency standby generator in the amount of \$1,250.00.

**Section 4:** The Mayor and City Clerk are authorized to execute a purchase contract with TAW Power Systems, Inc. of Riverview, Florida.

**Section 5:** The Mayor and Finance Director are authorized to make payment to TAW Power Systems, Inc. in the amount of \$48,000.00 from account number 305-0920-522-0-6405 and \$2,625.00 from account number 001-920-522-0-6405.

**Section 6:** This Resolution shall take effect upon its passage and approval by City Council.
